#### **UN-REDD Africa Regional Knowledge Exchange 2017**

'Navigating the Transition from REDD+ Readiness to Implementation'

#### **Extracts from online Event Satisfaction Survey results**

- √ Survey response rate: 100% (all 22 participants)
- √ **Overall satisfaction** with the event: **89%** of respondents found it **'very satisfying'** (remaining 11% noted it as 'moderately satisfying')
- √ **Event effectiveness**: **84**% found it as **'very effective'** in increasing their knowledge for the advancement of REDD+ in their country (remaining 16% found it 'moderately effective')
- √ **Knowledge sharing methodologies**: All participants (100%) rated the combination of methodologies used during the event as **highly effective for learning purposes**.


The event was characterized by an innovative knowledge exchange format that privileged spontaneous experience sharing over formal presentations, which were kept to a bare minimum. Sessions' design included roundtable conversations, World Café, talk show, radio news bulletin style group work, panel discussion, interactive plenary Q&As. Some of the knowledge harvesting techniques and tools included post-it notes, colour cards, online polls, before- and after-action-reviews.

The large majority (95-100%) indicated the knowledge gained during the event is useful both for their personal professional use, as well as for sharing with others (technical REDD+ practitioners & government decision-makers *in primis*).

- √ A strong call was made and supported by many participants for a UN-REDD online community
  of practice (or moderated mailing list platform and modality to be explored) to allow
  continuous and fruitful knowledge sharing among African countries.
- √ **Areas of knowledge improvement**: Participants perceived high levels of knowledge improvement in all technical areas addressed, and particularly with regards to **PAMs**, **REDD+Finance** and **Safeguards/SIS** (followed by FRELs and NFMS).
- √ **Issues for further UN-REDD support: SIS** came out strongly as the area on which a large majority of participants felt more UN-REDD support is needed.
- √ South-South knowledge exchanges was noted unanimously as the preferred modality for receiving support on the issues identified. The need for inter-regional cross-fertilisation (with LAC and Asia) was also noted by one respondent, as well as the need to invite donors to these exchanges (NB: Norwegian embassy representative attended the full first day of the event).
- √ Coordination with WB/FCPF and GCF: A strong request was raised by several partner country delegates throughout the event and in the final stock-taking plenary asking 'the three giants in the REDD+ universe' (UN-REDD FCPF GCF) to come together, create strong synergies and hold joint events.
- √ Other comments including from final discussions during the final stocktaking plenary noted the need to \*train lower-level technicians (not focus only on national focal points) as well as to \*unpack knowledge and bring it to community/IPs level.








### Q4 To what extent are you engaged in the REDD+ process?





# Q6 In your opinion, how did your knowledge of the following REDD+ areas improve as a result of the event?




