'Operationalizing and financing National REDD+ Strategies: from programming and financing implementation to Results-based payments'

#### **Extracts from online Event Satisfaction Survey results**

- √ **Survey response rate:** 96% (27 responses out of 28 country participants)
- √ **Gender: 41% women** participants
- $\sqrt{\text{Reach-out beyond foresty: 19\%}}$  of participants came from outside the forestry sector, including ministries of finance (x3), planning (x3), agriculture (x5), private sector, development banks.
- √ **Overall satisfaction** with the event: **87**% of respondents found it **'very satisfying'** (remaining 13% noted it as 'moderately satisfying')
- √ Event effectiveness: 100% of respondents stated their knowledge on REDD+ preparedness and implementation increased, and 75% found the event 'very effective' for the advancement of REDD+ in their country (17% found it 'moderately effective')
- √ **Knowledge sharing methodologies**: The large majority (96%) rated the combination of methodologies used during the event as **highly effective for learning purposes**.


The event allowed for ample space for participants' interaction, dialogue and brainstorming, through a combination of knowledge sharing formats alternated between the various sessions, ranging from break-up country groups, pub-style quiz, role play, moderated discussion panels, hands-on case study, vote-and-play, and fishbowl exercises. Engaging feedback methods were employed to maintain attention levels during group work reporting to plenary, including carousel, posters, colour cards, post-its, and various energizers. On the spot stocktaking by UN-REDD experts after each session ensured main take-away messages were made clear for each sub-topic. Moreover, daily morning reviews/refreshers aimed to ensure information delivered the previous day was assimilated and pending questions were addressed before introducing further content.

**Learning from leading technical experts** was valued highest (96%), together with group work and roleplay (92%), and **learning from the experience of other countries** (88%). Participation by **Green Climate Fund** experts (remotely), as well as cross-fertilization with Latin American experiences (**Ecuador** Min.Env participant, and **Chile** Min.Ag. remotely) added significant value to the event – as acknowledged by participants during final stocktaking and evaluation discussion.

The large majority (96-100%) indicated the knowledge gained during the event is useful both for their personal professional use, as well as for sharing with others (government decision-makers, technical REDD+ practitioners and policy experts).






### Q4 To what extent are you engaged in the REDD+ process?





## Q5 How effective was this event in increasing your knowledge for the advancement of REDD+ in your country?




