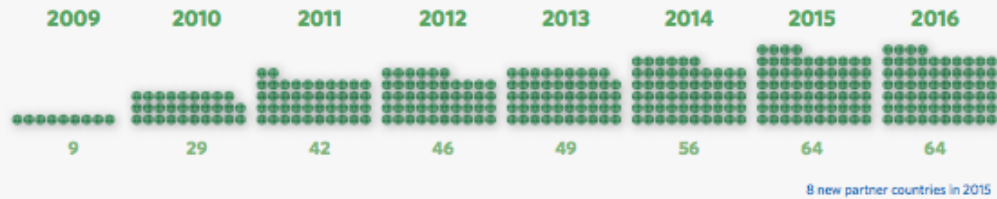

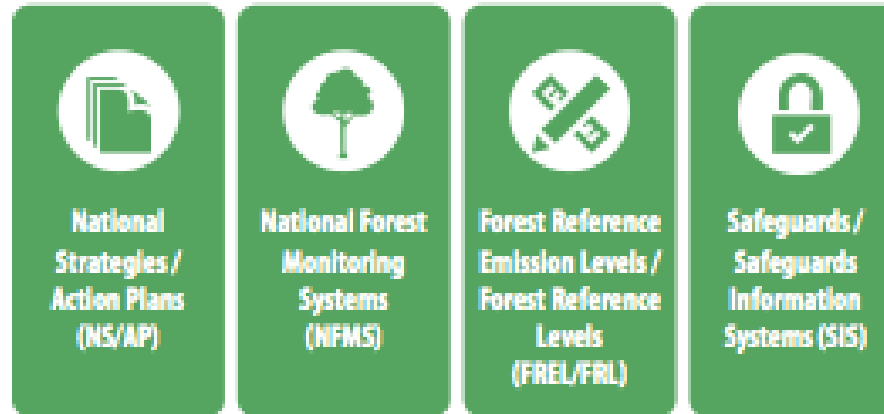

## Pillars of UNFCCC Warsaw Framework for REDD+



- **NS/AP:** 32 countries advanced national strategies/action plans; 12 countries identified and designed policies and measures
- **NFMS:** 40 countries advances on NFMS; 25 supported to improve Satellite Land Monitoring Systems; 17 made progress on national forest inventories
- **FREL/FRL:** **70%** FREL/FRL submissions to UNFCCC have received UN-REDD support (7 submitted in 2016/early 2017)
- **Safeguards/SIS:** 13 countries supported to meet country approaches to safeguards;6 made significant progress towards SIS publication



# Road to REDD+ Implementation

- Moving into the next phase:
  - Focus: countries making tangible progress
  - Ecuador - a UN-REDD supported pioneer
  - Transforming REDD+ strategies into investment plans

# Programme Fund Status as of 31 May 2017 (Millions)



## Contributions

- US\$293.1 - Total Deposits + Interest+ Commitment\*
- US\$ 290.4 - Funds Approved
- US\$ 272.2 - Funds Transferred
- US\$223.95 - Cumulative expenditures (2008 – 2016)
- 82.5% - Overall Programme delivery
- US\$ 9.0 - Cash balance with MPTF
  - Relates to pending funds transfer to Chile & Peru

\* Refers to EUR 9.6 million(\$10.4M) pending disbursement from the EC over 2017 - 2021
