

In May 2010, Indonesia signed a Letter of Intent (LOI) with Norway to support REDD+ through a contribution of USD 1 billion to be paid based on verified emissions



Preparation Phase, 2010

Strategic design and framework

- Develop national REDD+ Strategy
- Establish REDD+ Agency
- Develop funding instrument
- Develop independent Monitoring, Reporting and Verification (MRV) system
- Implement a 2-year moratorium
- Select pilot province

Transformation Phase, 2011-13

Implementation

- Launch funding instrument
- Launch MRV system st subnational level
- Implement programs in first and second pilot province (2011 and 2012)
- Enforce 2-year moratorium on new concessions on forest and peatland
- Develop degraded land database




Absence of an integrated map highlights the misalignment in regulations

Definition of primary forest according to existing regulations:

- Ministry of Forestry: pristine forests untouched by nature (ie. natural disaster) or anthropogenic means
- Ministry of Environment : high density forests as determined by satellite imagery
















Cluster of focus



- Working Group on National Strategy
- Working Group on Mainstreaming REDD+ into National Planning

- Finalization National REDD+ Strategy as a policy document
- Formulation of quick-win provincial action plans through a bottom up approach
- Drafting of REDD+ or low carbon development provincial strategy
- Mainstreaming REDD+ into national and regional planning using existing development mechanisms, such as the annual budgeting plan the National/Regional Medium Term Development Plan (RPJMN and RPJMD)
- Synchronization of development plan implementation, like the Master Plan for Acceleration of Economic Development (MP3EI), with REDD+

- Drafting of Presidential decree for the establishment of REDD+ Agency:
 - An independent agency (ie. not attached to existing angencies)
 - Reporting directly to the President
 - Authority as the designated national agency for REDD+ with strong governing, coordinating and monitoring functions
 - Tasked with implementing strategic programs/projects on the ground
- Development of a concept note on the funding instrument:
 - Trustee is an internationally reputable financial institution in partnership with a national financial institution
 - Efficiently manage funds from public and private sources
 - Disbursement to local levels
- Finalization of MRV strategy to develop monitoring and reporting systems in accordance to international standards and conduct independent verification

- Establishment of framework for collaboration for sub-national implementation
 - Operationalization of Joint Secretariat for Task Force and Central Kalimantan government in Palangkaraya
 - Development of planning of projects in the ex-Mega Rice area
 - Province-wide baseline mapping
- Monitor implementation of moratorium
 - Conduct bi-annual revisions of the Moratorium Indicative Map
 - Development of an integrated licenses database system and an integrated eregistration system for licenses to increase transparency and provide baseline for license review
 - Development of a registry for claims for indigenous land rights
- Legal review of existing regulations to determine consistency with REDD+ agenda and resolve potential overlaps
- Determine high-impact/high profile cases as strategic entry points for law enforcement to catalyze improvement in forest management and greater reform (eg. Mining and plantation enforcement in Central Kalimantan and Rawa Tripa cases in Aceh)


