#### Activities for 2012

#### **Proposed activities for 2013**

- Produce a document on lessons learned on the legal and regulatory aspects of REDD+ implementation at country level
- Organize an expert consultation meeting to share experiences and identify lessons learnt (September in Rome FAO Hqs)
- Develop a comparative review of climate change laws

 Upon governments' requests, offer direct legislative support for REDD+ in response to national priorities, including options to reform sectoral laws.



## Legal challenges posed by REDD+

- Definition of land and carbon rights and other REDD+ terminology to be included in national laws
- Formal recognition of customary and indigenous rights in statutory laws
- Identify major drivers of deforestation and degradation and harmonize legal inconsistencies across sectors
- Consolidate legal infrastructures ensuring REDD+ institutional coordination

### Legal challenges posed by REDD+\*

- Ensure that laws include public participation processes and free prior and informed consent mechanisms for REDD+
- Regulate decentralized mechanisms supporting REDD+ implementation at local level
- Develop and regulate benefit sharing distribution mechanisms
- Review and reform if necessary investment laws





### Methodology to enact legal reforms for REDD+ implementation

- **Collaborative**: suggestions for law reform provided alongside advice from technical experts
- Participatory: genuine involvement of all stakeholders concerned to accommodate multiple interests at stake
- Independent: disinterested advice drawing on international experience and based on objective analysis
- **Tailor-made**: laws drafted to meet particular needs and concerns of individual countries or specific regions

## Link to PGA

- LEG-REDD+ helps to address legal issues identified through the PGA
- Example of Vietnam LEG-REDD+ activities so far:
  - FAO-IDLO review of existing laws relevant to REDD+
  - National consultation workshop to validate the study (Hanoi, November 2011)
  - Ongoing process to identify lessons learnt, with a view to provide legislative support for REDD+ implementation
