Managing multiple forest and land-use interests

Lessons learnt on consensus building mechanisms from two REDD+ pilot project sites in Cambodia DRAFT (updated 26.12.2012)

Related Activities UN-REDD Workplan:

2.5A Assessment of options for linking subnational and national implementation (legal aspects) and conflict management and resolution mechanisms

Objectives:

To support the REDD+ readiness process by identifying potential consensus building mechanisms in case of forest and land-use disputes and suggest preliminary recommendations on how to strengthen them based on international best practices and observations at 2 REDD+ pilot project sites. In particular, the activities will directly contribute to:

- 1. Achieve the outcome 2.5 "Develop policy and legal framework for REDD+ implementation" through activity 2.5A "developing conflict resolution and independent review mechanisms" (UN-REDD Project Document, August 2011)
- Implement the Cambodia REDD+ Roadmap "strengthening conflict management and resolution mechanisms, as mandated under the NFP and 2008 PA Law; review suitability of these mechanisms for REDD+ and recommend modifications as required" (Component 4.1 Cambodia REDD+ Roadmap, March 2011)
- 3. Address FCPF recommendations to revise the R-PP submission, in particular 2 a) "provide a rough roadmap to improve forest governance issues [...] which are necessary for REDD+ to succeed" (Technical Advisory Panel Review, Comments and Recommendations, March 2011)
- 4. Identify priorities to focus the expected activities under the additional FCPF 200,000 USD fund for "proposed feedback and grievance redress mechanism to be operational early in the R-PP implementation phase" (FCPF Guidelines for Establishing Grievance and Redress Mechanism at Country Level, April 2012)

Context:

Forests, through the provision of multiple ecosystem services, support the needs of a number of stakeholders. When people with different priorities as well as social, economic or political interests interact, disagreements are likely to arise. In Cambodia, the strong dependence of the people on agricultural activities for their livelihoods, the relative high rate of land use change, as well as the recent history that resulted in recreating cadastral mapping almost from scratch, are also contributing to cause tensions over forest and land use in the country. Recently, the Royal Government started and initiative to demarcate several hectares of the territory, which will allow officials to issue land titles.

When disputes occur they are managed by the Royal Government and local authorities within the existing legal regulatory framework that includes the 2001 Land Law, the 2005 Sub-decree, the 2008 Protected Area Law, and the 2002 Forest Law, among many others. There are five formal Royal Government bodies responsible for handling land related disputes the Commune Councils (reconcile differences of opinion only, usually the first step for all cases), the Administrative Committees (conflicts during the land registration process), the Cadastral Commission (disputes over unregistered land), the court system (disputes over registered land, contractual and inheritance issues), and the National Authority for Land Conflict Resolution (for cases beyond the competence of the Cadastral Commission).

However, the enforcement of these regulations and procedures is often challenged by the competing interests in forest lands from different state and non-state stakeholders that, if not properly addressed, risk undermining peace and development efforts.

Approach:

The the Oddar Meanchey Community Forestry and the Steung Siem Reap Watershed/Kulen Promtep Wildlife Sanctuary, two REDD+ demonstration projects in the northern territories of Cambodia, are the selected sites for this study.

By consulting with key local stakeholders at the project site as well as national stakeholders, the mission team will increase the understanding on sources of disagreement over forest use and existing consensus building mechanisms, how they differ in relation to management objectives, and how they can potentially be strengthened within the existing context.

The fact that the two projects are implemented in two different land types, productive forests and protected areas, and thus fall under the management and regulations of two different government agencies and sub-national authorities allow the mission team to have a general overview of the institutional context regarding the Forest sector in Cambodia.

Overview of the activities:


The following key activities will be carried out during the 5-day visit:

- 1. Conduct scoping meetings to verify and collect additional information on existing mechanisms and practices to resolve disputes related to forests with key stakeholders at national level, including:
 - Forestry Administration (FA) of the Ministry of Agriculture, Forestry and Fisheries (MAFF),
 - General Department of Administration for Nature Conservation and Protection (GDANCP) of the Ministry of Environment (MoE),
 - Selected REDD+ Taskforce members (Ministry of Land Management Urban Planning and Construction, MIME, MoE, MAFF)
 - Ministry of Justice,
 - Civil Society Organisations (CSOs) and Indigenous People (IP),
 - Community Forestry and Community Protected areas networks,
 - REDD+ Pilot project implementation partners (WCS, PACT Cambodia/Children Development Association);
- 2. Collection of information on consensus building mechanisms at field level (visit of REDD+ Pilot Project sites and/or focal group discussions):
 - local authorities involved in the management of forest disputes (Commune Council, local cluster of GDANCP, FA cantonment)
 - NGOs implementing project activities and key facilitators;
 - local stakeholders and communities members with different interests on forests (Chiefs of Community Forestry and Community Protected Areas)
- 3. Consolidate the findings from the observations and discussions and develop possible options and recommendations to strengthen consensus building mechanisms related to REDD+ activities in Cambodia.
- 4. Debriefing Seminar with presentation of preliminary results and recommendations to key stakeholders in Phnom Penh.

Key Outputs:

- ➤ Presentation of recommendations and best practices on how to strengthen existing forest and land-use consensus building mechanisms to key national stakeholders involved in initiatives related to forest conservation and development.
- Working paper summarizing international best practices suitable for Cambodia and the analysis carried out during the mission and the resulting preliminary recommendations.
- Indicative plan that describes an approach with key milestones for strengthening consensus building tools for REDD+ in Cambodia, taking into consideration existing capacities and mechanisms.
