# 1. Nature of services

# Terms of Reference Building awareness and support REDD+ among forest dependent communities around Siam Reap

#### Background

The project involves a community forestry area in Siam Reap and will analyze how community forestry can be integrated as an important part of REDD+. This project analyses and identifies the challenges, constraints, and opportunities for communities to be involved in REDD+, the current needs for increasing awareness of the target stakeholders, and the effective means to strengthen the institutional arrangements of community forestry groups. In achieving these goals, consultation meetings and forums to promote awareness on the benefits and local costs of REDD+ will be conducted and findings and recommendations useful for the broader implementation of REDD+ in community forestry areas in Cambodia will be developed.

The project is expected to:

- Increase awareness about REDD+ among CF stakeholders on REDD+ and the incorporation of REDD+ options in the CF Management Plans
- Identify challenges, constraints, and opportunities in implementing REDD+ including local costs of implementing REDD+ and identify approaches to motivate participation of CF in REDD+
- Motivate wider participation in REDD+; and
- Improve/strengthen the implementation of REDD+ in Cambodia among the CF communities.

The primary beneficiaries of the project are the CF communities.

#### **Expected Outputs and Deliverables:**

- Increased awareness about REDD+ and climate change among CF members;
- Identification of the activities that can lead to reducing and halting the loss of forest carbon stocks or increasing forest carbon stocks;
- Synthesis of lessons learned on REDD implementation that includes analysis of the constraints, challenges, and opportunities of implementing REDD+ in the CF areas including the issues related to local costs and benefits of implementing REDD+.
- Report with 1) a proposal for appropriate and effective methods to involve CF communities in REDD+ implementation which will address costs and benefits and with 2) suggestions for the appropriate incentive based systems for involving the CFs, including possible alternatives to REDD+ ex-post result-based payments for emissions reductions.
- Draft policy notes on REDD+ implementation in the CFs that include 1) background of CF and REDD+, 2) challenges and opportunities for CF under REDD+ and 3) recommendations for CF under REDD+.

### Supervision, teamwork and administrative support:

The Consultant will report to the UN-REDD National Programme Director and on day-to-day basis will be supervised by Dr. Sokh Heng, Forestry Administration and the REDD+ Taskforce Secretariat.

## **Monitoring and Progress Control**

The Consultant will be accountable for timely and quality outputs and report monthly to the REDD+ Taskforce Secretariat on progress compared to the work plan.

#### **Payment milestones**

The Consultant will be paid on a lump sum basis under the following installments

- (20 %) 1st payment, upon submission and acceptance of work plan of the assignment
- (20 %) 2nd payment, upon submission of synthesis reports based on meetings held
- (30 %) 3rd payment, upon submission of report on synthesis report of lessons learned
- (30 %) 4th payment, upon submission and acceptance of the policy brief

## Functions/ Tasks expected for the National Consultant:

- 1. Provide full information to and incorporate inputs from Forestry Administration (FA), CFs and local authorities with regard to the project objectives and activities;
- 2. Coordinate with related projects and initiatives to ensure greater impacts of the project. Including the awareness raising conducted among communities by RECOFTC in order to ensure consistency in the information about REDD+ to the communities.
- 3. Promote dialogues and inputs from local and national partners into key project outputs;
- 4. Work closely with the International Consultant in conducting baseline surveys and interviews.
  - a. In collaboration with the international consultant, implement the baseline survey in the target CFs using the tools developed by the Project Team. Assist the International Consultant in reviewing and improving the baseline study design for approval by Dr.Sokh Heng, Forestry Administration.
  - b. Assist the international consultant and oversee the conduct of the baseline study to assess the awareness level of REDD+ among CF members. This task entails 1) translating surveys in Khmer, and 2) organize the survey team that will conduct survey and interviews with the target groups including finding translators, and 3) oversee and supervise the works of the international consultant as provided in the TOR.
- 5. Organize and conduct consultative meetings at village, commune and province levels in order to:
  - a. determine the current level of awareness of REDD+;
  - b. find opportunities and challenges in implementing REDD+;

- 1. Assessment of existing benefit sharing models used in Cambodia and other parts of the world relevant for REDD+ in Cambodia;
- 2. Consultation on results from the assessment under 1. and
- 3. Development of up to four preferred options for benefits sharing for REDD+ in Cambodia

clarification and likely issuance of land tenure for communities and increased rural incomes and preservation of important ecosystem and environmental services and biodiversity.

With the completion of the REDD+ roadmap (2011) which defines key steps for Cambodia to be ready for REDD+ implementation, Cambodia has taken a first important step towards REDD+. The national REDD+ programme in Cambodia has also been supported by UN-REDD, CamREDD and other supporting frameworks that aim to build the national capacity to plan and implement REDD+. Since 2008, two REDD pilot projects have been implemented to test and learn from on the ground REDD+ activities. Despite numerous important initiatives having been undertaken, there remains a critical need for capacity building efforts for various actors involved in REDD+ including the issues of benefits sharing, and multiple benefits and costs associated with REDD+.

A decision on how to distribute benefits and to whom and in what forms at different levels will require careful analysis of possible options suitable to the national circumstance of Cambodia. For this reason, there is a need to assess and learn from national as well as international experiences with regard to benefit sharing mechanisms used in the forest sector (e.g. Payments for and REDD+ pilot projects). Such decisions will also require extensive consultation with relevant governments at national, provincial and local levels as well as discussions with all relevant stakeholders in order to ensure a common understanding and broad acceptance of a benefit sharing mechanism that is suitable for Cambodia. At the same time, ensuring the full and effective participation of all relevant stakeholders will contribute to avoiding the creation of unrealistic expectations about REDD+ benefits which in some cases has been noted as a problem in the past.
