Concept Note Introduction to REDD+ and Stakeholder Engagement Training Course Date: 21 February 2013, Thursday Venue: FA Meeting Room, Phnom Penh, Cambodia

Introduction

The Cambodia UN-REDD Programme plays a significant role in the Royal Government of Cambodia's efforts to get ready for REDD+. The programme, which was specifically designed to support implementation of a REDD+ Roadmap, has four outcomes:

- 1) National REDD+ Readiness Management arrangements and stakeholder consultation;
- 2) National capacity-building towards development of the REDD+ strategy and implementation framework; and
- 3) Sub-National REDD+ capacity-building and demonstration;
- 4) Support to development of the Monitoring system.

The programme is designed to fully engage with relevant government institutions such as FA/MAFF, GDANCP/MoE and FiA/MAFF within the implementing structures, while other ministries are engaged within higher level decision making bodies as well as technical assessment and consultation processes. This integration is reflected in the composition of the Programme Executive Board (PEB), a multi-stakeholder body that provides oversight to the programme. As such, it marks the programme out as one of the most highly integrated UN-REDD programmes globally.

Continuing the efforts to ensure full and effective participation by civil society (CS) and Indigenous Peoples (IP) in the design of a robust national REDD+ strategy, the REDD+ Taskforce Secretariat built upon existing structures for stakeholder engagement, and organized an intensive consultation processto elect one CS and one IP representative to the PEB. The process which began in February 2012, culminated in a national workshop in September 2012 where two interim representatives were elected respectively. Efforts are now on-going to reselect a permanent IP representative to the PEB. Similar but separate efforts will soon commence for the permanent CSO representative to the PEB. Accordingly, the training course is designed to reflect upon, and strengthen existing process by revisiting fundamental concepts.

Key course objectives

The training course aims to

- 1. Provide a basic understanding of REDD+ and its development at the international level, and more specifically in Cambodia;
- 2. Establish the relationship between forests and indigenous peoples;
- 3. Introduce the guiding principles of stakeholder engagement; and
- 4. Learn tips to be a better communicator.

Expected outputs

At the end of this training course, participants should be able to

- 1. Explain the basics of REDD+ and the development of a national REDD+ strategy in Cambodia;
- 2. Explain the importance of forests to indigenous peoples;
- 3. Design stakeholder engagement processes more strategically; and
- 4. Communicate key messages more effectively.

Target audience (Maximum 12- 15 persons)

- 1. Team members facilitating the IP reselection process; and
- 2. REDD+ Taskforce Secretariat.
