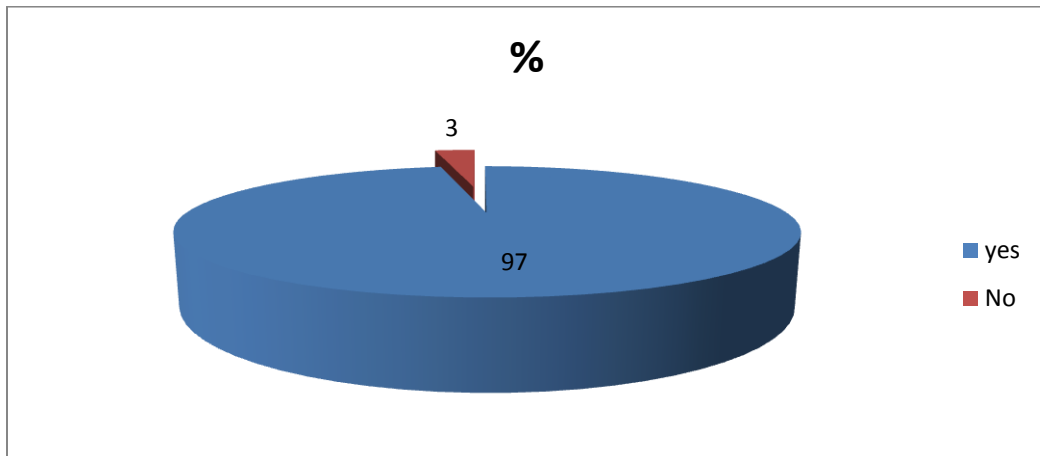

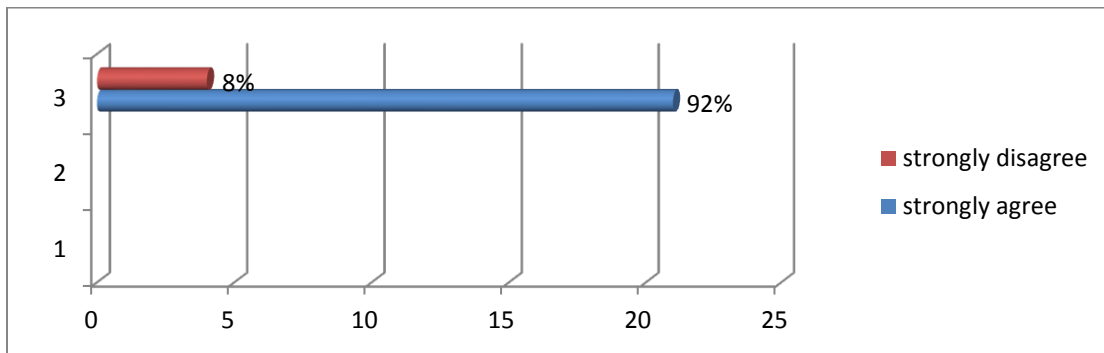

1. Did the workshop meet the expectations of the participants

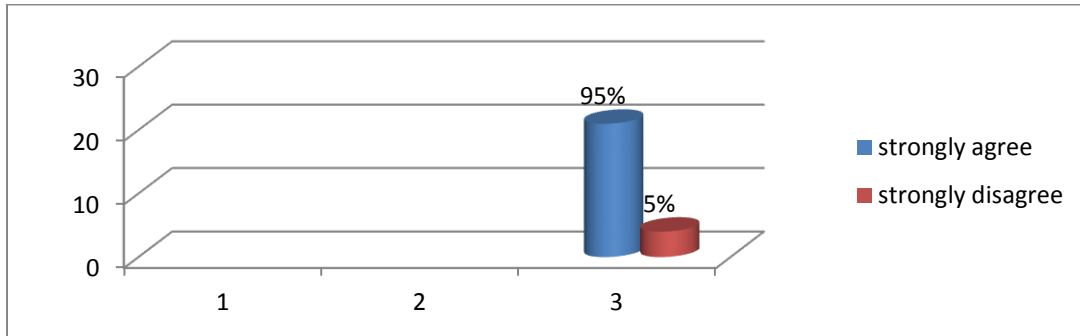

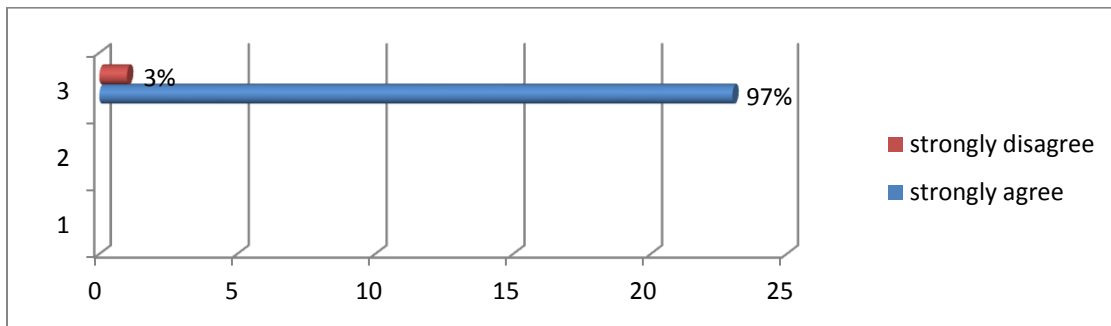

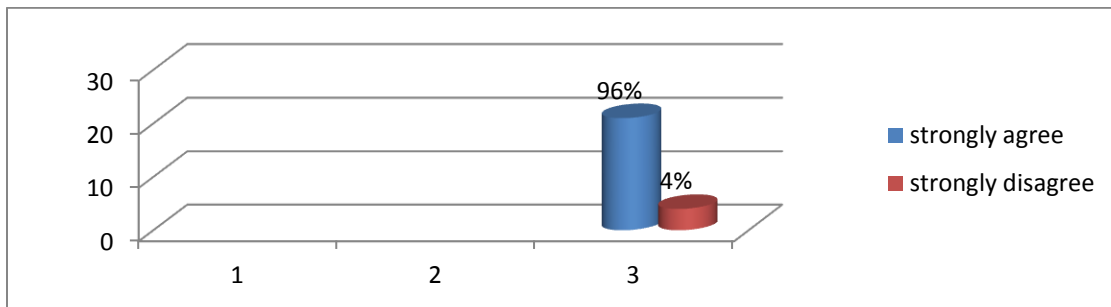

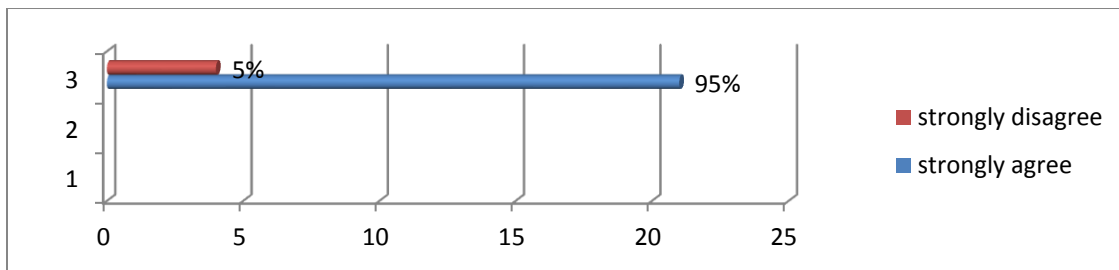

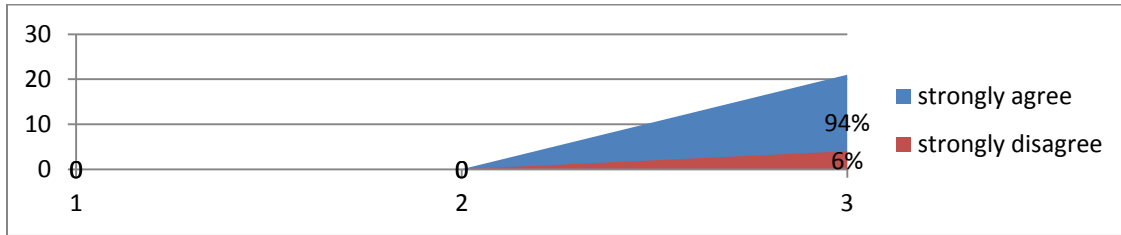

I. Yes response

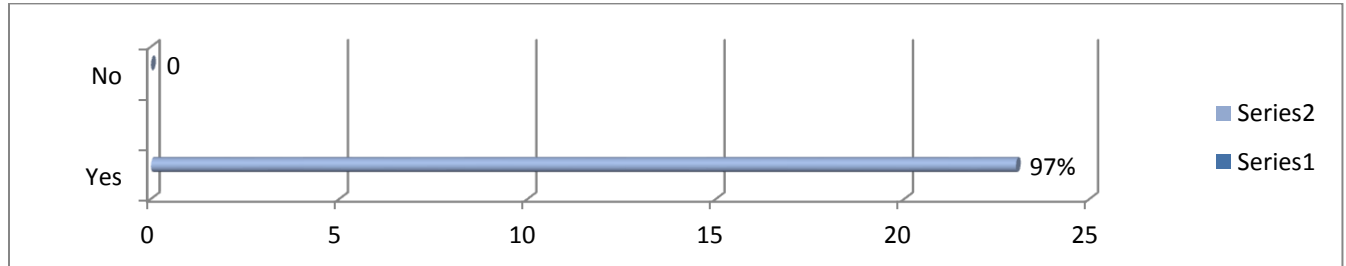
- But next time lets have better language translations.

Reasons for the Yes response:

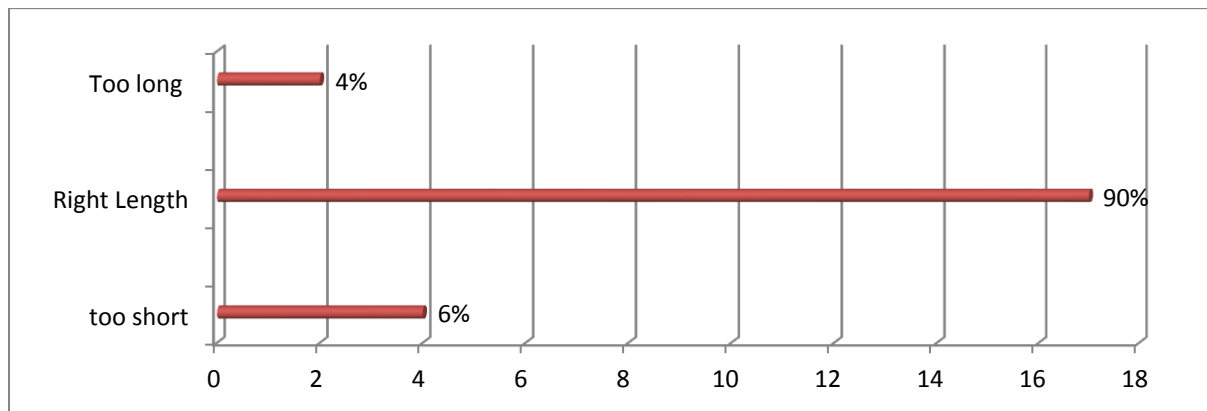
- I. Got more understanding of PAMs

- VI. Excellent exchange of experiences.
- VII. Perfect intel on REDD+ finance and economics.
- VIII. It unpacked issues of governance, safeguards and their importance to the success of REDD+.

5. Lessons learnt from the participants during the workshop.

- I. All stakeholders must participate in the REDD+ process and be part of decision making and also in designing comprehensive REDD+ strategies
- II. Experiences from other countries is important in improving REDD+ in particular countries.
- III. REDD+ is beyond Carbon benefits.
- IV. Marginalized people like women need to be engaged in REDD+ and the climate fund for example has set funds to empower them.
- V. Charcoal is a complex driver and to address it all stakeholders need to come together.
- VI. REDD+ is a cross cutting issue and should not be treated as a forestry issue alone.
- VII. There is a need to explore possibilities of using subnational approaches.
- VIII. Poverty is a key underlying cause to most drivers of deforestation.

- IX. Definition of forest can change from Country to country.
- X. REDD+ lessons should be applied and anchored to national development.

7. Suggestions and comments from the participants for future improvement.

- Improve after workshop socialization.
- More such meetings should be held to clarify certain issues that improve ongoing dialogues on REDD+ goals, objectives, PAMS & legal framework.
- Need to hold more consultations on Warsaw framework.
- Participants should be encouraged to make sharp, concise interjections and comments to save time during the plenaries.
- Payments for DSA should be in dollars.
- More recreation activities should be organized during the workshop.
- Presentations should be translated in advance.
- Logistical arrangements should be improved for e.g some participants got stranded at the airport since there was nobody to attend to them.
- Capacity building for junior staff at the sub national level should be looked into.
- Travel arrangements should done appropriately for e.g if the workshop ends on Friday participants who want to travel back on that Friday should be able to do so to avoid further expenses.
