9 Brief summary of the mission:				

9. Brief summary of the mission:

The purpose of this mission was to support the PMU in facilitating the drivers of D&D stakeholder validation meeting, and to provide backstopping for the planning (ie. 2015 AWP) and implementation of the UNDP led activities.

The mission delivered the following outputs successfully as planned.

- Summary note from the stakeholder validation meeting on the study of drivers of D&D.
- Agreed ways forward with the Colombo University Cell for the finalization of the report on the study of drivers of D&D.
- Revised AWP 2015 for the UNDP led activities.
- Ways forward with the CSO Forum for the delivery of NCB and gender outputs.

10. Findings/Recommendations:

- Stakeholder validation meeting on the study of D&D Drivers went successfully the participants were generally satisfied with the current version of the report (see Annex One: summary note).
- PMU (MRV team) will provide a national carbon emissions profiles by sector to support the application of the drivers study findings to identify prioritised PAMs and national REDD+ vision and scope during Q1 2015 from the overall carbon mission perspective in order to support the integration of REDD+ into the national climate framework.
- Based on the most recent updates (September 2014) on the NP indicators and targets, the implementation timeline for the entire programme was adjusted for the UNDP-led outcomes, outputs and activities (FAO and UNEP also did the same for their respective parts) and based on which the AWP 2015 was readjusted and finalised.
- This timeline adjustment exercise has confirmed that the NP will require a no-cost extension of 12 months to complete the programme (ie. until end of Q1 2017).
- Given the upcoming presidential election in January 2015 and expected political uncertainty following it, the UNDP senior management has suggested to make a request for a no-cost extension to the PEB at the first meeting in 2015 instead. The UNDP senior management will in the meantime suggest to FAO and PMU to ensure contingency planning, especially to ensure there is adequate resources available to maintain required functions of PMU.
- Discussion with a representative of CSO Forum has concluded that formal contracts are required to implement the Forum's work plan - a single fund receiving entity will be nominated within the Forum, and its internal financial management arrangements will be identified.
- A call for proposal to implement the TS on gender will be issued the CSO Forum has suggested the work to be done by a specialised group of experts in the country while working closely with the Forum to help build its capacity in the area during the course of its implementation.
- Discussion with the PMU manager and UNDP focal point has concluded that greater work integration within the PMU is required, and the regional advisors' role should be more focused on technical quality assurance.

Objective

Following a series of stakeholder consultation meetings at national and subnational levels during the study on drivers of deforestation and forest degradation, this was the final stakeholder consultation/validation meeting with an aim to provide key national stakeholders with one last chance to raise any outstanding issues with the current report on drivers of deforestation and forest degradation, and to obtain their consensus to complete the study and to finalise the report with the next iteration.

Approach

The majority of the participants had been consulted prior to this meeting to provide their feedback on the previous versions of the report, and the latest version was circulated to the participants one week prior to this meeting. The participants were asked to identify any outstanding issues still remaining in the current version.

After a short presentation on key findings from the study and where and how recommendations from the previous consultation meetings have been addressed in the report, the participants were ask to discuss any outstanding issues and recommendations to be considered in the next iteration through group and plenary discussion sessions.

The team of consultants, FD and UN-REDD Programme felt that there were a number of under explored areas/items under the section on potential policies and measures (PAMs) in the report. The participants were thus asked to focus their PAMs related recommendations on these areas/items indicated below.

- Future infrastructure development projects
- Private agriculture ventures
- Economic development zones including tourism zones
- Power generation, specially coal power

Decisions:

The participants were generally satisfied with the current version of the report. With the following recommendations reflected in the next version, the report can be finalized.

During the breakout group discussion session, the participants were divided into two groups and discussed and agreed on their collective recommendations to be considered in the next iteration. During the plenary session, those suggestions and recommendations were presented and discussed. The participants collectively identified and agreed on a specific way forward for each recommendation as shown below.
