The objective of this mission was to support the PMU in finalizing/reviewing- 1) the process of PAMs refinement, 2) the on-going process of safeguards development, and 3) the work plan for the National REDD+ Strategy completion and in designing: 4) an approach to PAMs financial planning, and 5) terms of reference for institutional capacity development action planning.

10. Findings

work steams.

National REDD+ Strategy development /PAMs elaboration

- PAM profiles, especially their goals and outcomes, needed closer assignment with REDD+ to keep the primary focus on addressing drivers of D&D and forest enhancement thus emission reductions/removals while contributing at the same time to improved the overall environmental governance capacity.
- Further review suggested reducing the number of PAMs from the current 22 to 16.
- For instance, seven PAMs under 'Other Forested Lands' were merged into three: 1. Support to Vihara Devalagam, JEDB, SLSPC, RPCs & LRC forested lands (a shared steering committee to handle the demarcation of private forested lands, conservation easement, data based/survey), 2. Support the acquisition of natural forest lands under LRC & GPC, and 3. Identify local supply chain for fuelwood demand.
- National REDD+ Strategy preparation process must be handled carefully and strategically to ensure successful
 transition to its implementation by the Government with that in mind, although the UNDP CO had planed to
 operationally close all activities by Dec 2016, it has been now agreed that additional 2 months in 2017 be added
 to ensure proper translation, editing and formatting, etc. of the Strategy document and to support the official
 launch by the Government.
- UNDP CO Senior Manager has agreed to withhold US\$ 18,000 from the 2016 budget to be spent in 2017 for the above reasons, but all contracts should be issued within 2016 (see the revised work plan below).
- To support the implementation of the National REDD+ Strategy, UNDP will work with the FD and NDA of GCF to explore a possibility of putting forward a funding proposal to the GCF.

Safeguards and SIS development

- In relation to the "respected" aspect of Sri Lanka's safeguards, the PMU will advise the team working on safeguards to derive a list of capacity development actions to be followed up. The actions will then be costed and put together with the integrated action/financial plan under the National REDD+ Strategy.
- Safeguards information system structure was discussed, and a design was proposed—I will help the PMU by starting populating the structure after safeguards risks/benefits and PLR analysis results have been handed in by

the consultants.

- For capacity development actions in relation to the SL safeguards, the team of consultants will apply the following capacity categories for the purpose of aligning the structural aspect of actions with institutional capacity assessment results:
 - a. Enabling environment (political context and institutional vision)
 - b. Organizational (technology, finance, procedures and coordination)
 - c. Individual (skills, knowledge and attitude)

PAMs action/financial planning

- The integrated PAMs action and financial plan will also include capacity development actions from SIS, NFMS, SE, and in relation to specific roles and responsibilities of key institutions, and also management costs required for the overall coordination of the Strategy implementation.
- For quick reference by policy makers and donors/investors, the integrated PAMs action and financial plan will also include information on safeguards and CO2 targets regarding each PAM.

Institutional capacity assessment

- Institutional capacity assessment will look at current mandates, functions, and operational capacities of those intuitions that are expected to play key roles and responsibilities in operationalizing the Warsaw Framework the competency framework developed for the NP in Mongolia will be adapted for the Sri Lankan context.
- TOR for capacity assessment was reviewed and finalised.
- Candidate consultants to be recommended from the regional CC roster.
