9. Brief summary of the mission:

The UN-REDD Phase II Programme in Vietnam has been operating since 2013 with the objective to support Vietnam to benefit results-based payment from their REDD+ implementation by the possible improvement of forestry sector and emissions demotion. However the phase II has been a slow implementation process since it started. By the end of 2014, at two-thirds of the planned lifetime of the programme, none of the expected outputs have been fully completed and the total amount spent accounted for about 10% of the total programme budget, USD 30 million. The slow process however has been said due to many reasons varied from weak technical support, coordination among the three UN-REDD agencies to the slow decisions making process of the government of Vietnam.

To address some of these issues, during the Vietnam Phase II Preparatory UN Joint Mission Meeting in late March 2015 it was decided that a UN Technical Team was to be established. Under the empowered leadership and coordination of the CTA as the main technical focal point for the programme, the TT will:

- Jointly ensure the coherence of programme strategies and technical advice to national counterparts;
- Work towards a common technical strategy and resolve matters of technical divergence in the interest of the best overall optimal solution for the country;
- Provide coherent advice to LFA on risks and issues that escalate from the risk log; and
- Build capacity for Programme technical staff (i.e. Outcome officers and other national technical officers hired under the PMU)

Members should consist of lead technical advisors from the three UN agencies that are involved in defining programming strategies for Vietnam UN-REDD Programme and other concerned staff will participate as necessary.

- CTA (Anders);
- Technical (Shyam, Heang);
- FAO (Akiko, Ben, FAO Natn'l Coordinator);
- UNDP (Tim B, Hung, Celina, Berta);
- UNEP (Thomas, Phuong, Charlotte); and
- Other UN-REDD global/regional technical advisors as needed.

The mission is to support KM and Communications aspects and discussion to find ways forward. As in the agenda, the meeting included discussions on (1). A follow-up discussion on in-country event with relevant people and progress, (2). Knowledge Management and sharing plans between country and regional offices, (3). A follow-up on the suggested Communications Mechanism Plan, and (4). Discussion with Communications Officer how to better move forwards with communications activities and strategy and the In-country "REDD+ Academy" Event.

Discussion on Regional Knowledge Management, Vietnam In-country Event, Proposed Communications Mechanism

- Presentation on KM, In-country Event and Communications was made to all members during the first TT meeting. The objective
 of the presentation was to brainstorm ways forward on organising the In-country Event and how the proposed communications
 mechanism should be further promoted. Due to lack of time, there was little opportunity for discussion, but it was proposed that
 the issues would be best discussed directly with the Comms Officer.
- Later the discussion with Comms Officer took place at PMU Office and it was suggested that the In-country event would need to
 re-adjust the approach. For communications work, it is noted that a VRO Comms Officer is being recruited and it is this person
 who should lead in coordinating and implementing the proposed mechanism. Once this person is on board the subject to be
 discussed further.
- Summary of the revised design/approach of the In-country will be developed by Heang according to the results from the discussion with PMU/Comms Officer.

9.b Results achieved (key outputs)

- A plan for knowledge management for UN-REDD in Asia/Pacific was presented to ensure that everyone knows and it is in line with country's needs.
- Vietnam In-country event concept was re-discussed with Comms Officer and further approach needs to be revised. Comms Officer will later develop action plan to submit to the NPD/DNPD of the PMU for further comments and feedbacks.
- Communications mechanism will be re-presented to the VOR Comms Officer once s/he is present.

9.c Expected outcomes and impacts

- The Vietnam In-country event will be organised with efficient and effective way.
- Communications mechanism will be improved and implemented by the VRO Comms Officer as a lead facilitator to coordinating
 with different REDD+ initiatives.
- On-going support to the Communications Officers will be available in terms of KM and communication to ensure that the quality of products is met.
