1.2 Monitoring Framework

Outcome 1: Effective National Management of the REDD+ Readiness process and stakeholder engagement in accordance with the Roadmap principles

Progress towards outcome: Significant progress has been made on Outcome 1: The Taskforce has been formed with representatives from key ministries and began the first of its regular meetings in November 2013. Activities of the Taskforce include national technical meetings, seminars, workshops, and forums on increased understanding of REDD+ and contribute to development of a REDD+ framework. The Taskforce has also been involved with REDD+ strategy development and has organized five meetings on REDD+ strategy development. In addition a study tour for Taskforce members was arranged to REDD+ projects in Vietnam to enable them to gain an improved understanding of different approaches to REDD+ and to enhance their capacity.

A Voluntary Facilitation Committee was formed to support selection of members to the Consultation Group and 18 members was elected by each of the nine constituencies at a national workshop held in August 2013. A special process for IP representative selection was conducted in 15 provinces with each province sending its representative for final selection at the National level. Following the selection, all Consultation Group members, including IP representatives, have been provided training on REDD+ concepts and six meetings have been organized to on eliciting inputs to the REDD+ framework development. In addition Consultation Group members have facilitated consultative meetings on REDD+ Benefit sharing and Safeguards at the provincial level jointly with the Technical Teams.

All the four Technical Teams were established in 2013 and have been functioning since early 2014. All these Teams have been provided with technical orientation and concepts on REDD+ that are relevant to their tasks and roles. The Safeguards and Demonstration Technical teams have made a field visit to a REDD+ pilot project to enhance orientation on practical implementation. Each team is now adept at managing its team meetings, workplan and contributes to technical elements of the National REDD+ strategy.

The Cambodia REDD+ Website was launched in May 2013 and a Communication Strategy has been developed and approved. A Photo Contest and Concert was organized in December 2013 at which event REDD+ extension materials were distributed. A review group was established to review existing communication material on REDD+ in order to identify gaps, and make recommendations for improvements. A survey among stakeholders on their level of awareness of REDD+ was undertaken. The UN-REDD programme activities and its achievements have been uploaded in the UN-REDD workspace. REDD+ outreach material such as: a video on introduction to REDD+; REDD+ glossary; booklet on COP decisions; brochure on REDD; and, five editions of the REDD+ Cambodia quarterly newsletter in English and Khmer has been produced.

Eight training events on REDD+ concepts have been organized for the Consultation Group, Technical Teams, Indigenous Peoples, and representatives of Community Forestry, Community Fisheries, Community Protected Areas, NGOs and staff from key forestry sector institutions. These events were attended by 333 participants. Ten pool trainers were selected and facilitated training at the provincial level.

Target achieved. The Cambodia REDD+ Website is updated regularly. The UN-REDD programme activities and its achievements have been uploaded to the UN-REDD workspace.

To strengthen awareness raising and enhance participation a Consultation and Participation Plan has been developed. A follow up workshop on Awareness Raising and the Consultation and Participation Plan has been planned.

The Communication Strategy for Cambodia REDD+ programme was finalized. Three editions of the REDD+ Newsletter were published. A booklet that summarizes COP decisions was produced, and, a REDD+ glossary is being translated to Khmer. To elicit feedback of the four Technical Teams to drafts of REDD+ extension material a two-day workshop was organized in July 2014. This forum brought together all the Technical Teams, selected INGOs, FA and GDANCP and secretariat staff. The feedback on planned multi-media extension material that includes posters, brochures, video, TV, and radio programmes will enable production of quality and relevant products for dissemination to stakeholders.

Two National training events and six Provincial training events on REDD+ concepts were organized with a total of 333 participants from the REDD+ Consultation Group, REDD+ Technical Teams, Indigenous Peoples, Community Forestry, Community Fisheries, Community Protected Ares, INGOs and Government staff. Ten pool trainers were selected and facilitated six training events on REDD+ at the provincial level.

Outcome 2: Development of the National REDD+ Strategy and Implementation Framework.

Progress towards outcome: The three agencies of FA, GDANCP, and FiA have been involved in activities to identify relevant contributions to REDD+ implementation. The FA is implementing the project titled: Building the Awareness and Support of REDD+ among Forest-Dependent Communities in Siem Reap Province: Community level workshops were organized to present and share experiences and lessons learned from the field visit to Oddar Meanchey REDD+ project. A consultancy report on the results from the study tour and workshop has been submitted.

The GDANCP is responsible for the project titled: Development of National Protected Areas Strategy Management Plan. Two national consultants and one international consultant have been recruited. Field assessments and sub-national consultative meetings on the current status and management of protected areas were conducted in June 2014 to protected areas in Northeast and Southwest regions.

The FiA leads the project titled Conservation and Reforestation of Flooded Forest and Mangroves for Carbon emission prevention: Volunteers to protect flooded forests and mangroves conducted Regular patrols. Communities have been provided with technical assistance to produce seedlings for flooded forest and mangrove plantation. Local communities and local authorities have become aware of the role of flooded forest and mangrove in Carbon emission and retention. A five year implementation plan will be developed; deforested areas will be reforested, and, effective management system will be established

A planning workshop on Valuation of Forest Ecosystems and Costs and Benefits from REDD+ implementation in Cambodia was organized in April 2014 and had 33 participants. Reports on Valuation of Forest Ecosystem and Costs and Benefits from REDD+ Implementation in Cambodia and workshop proceeding have been produced. Multiple activities related to valuation and cost and benefits have been combined as one activity under Costs and Benefits of REDD+. A concept note on this activity was developed and two national consultants are being recruited for these activities with technical assistance from WCMC and UNEP.

The Benefit Sharing technical team in 10 provinces organized a one-day provincial consultative meeting on Benefit Sharing. A total of 516 participants from the provincial authority, Technical departments, Indigenous Peoples, local communities, ELCs and INGOs were invited to these consultations. Reports on these provincial meeting have been submitted to the RTS. A final report on REDD+ Benefit Sharing is being produced.

A report on the Assessment of Existing fund mechanisms was translated and shared with relevant institutions for comments. Summary findings of this assessment were presented at the fifth Taskforce meeting. The Taskforce has endorsed a further study to refine a proposal for REDD+ Fund. The concept notes for further development of a proposal for a National REDD+ Fund and ToR for national consultant were developed and UNDP global and regional advisors are providing technical assistance.

Building on the findings and recommendations of the REDD+ scoping mission in January 2013, a concept note for Design of a REDD+ grievance mechanism for Cambodia has been developed. A call for consultants is being announced.

A Preliminary Review of Safeguards for REDD+ in Cambodia has been undertaken and translated into Khmer .concept note for four Regional consultative meetings on Safeguards Preliminary Review was developed and a national consultant has been recruited. The consultations will be held through July-August 2014.

The Taskforce has endorsed the development of the National REDD+ strategy. A consultant has been recruited, workplan and timeline for developing the strategy has been endorsed and the broad content has been shared for inputs with technical teams and related professionals.

The four Technical Teams on Benefit Sharing, Safeguards and MRV have been active through regular meetings, and providing inputs to ToRs, research frameworks, and participation in national and provincial consultations. A major new development is the establishment of a "gender team", whose mandate includes capacity building of the Taskforce, Consultation Group, and Technical Teams, and review of components of the National REDD+ Strategy as it emerges.

Regular PEB meetings have been held and have provided policy guidance. Field visits to enhance capacity have been organized within Cambodia, and also to Vietnam. Four regional workshops on Safeguards have been planned and a technical paper that has reviewed national and international safeguard mechanisms is being finalized. Significant progress has been made in enhancing stakeholder engagement by organizing meetings with the Consultation Group and the finalization of a Consultation and Participation Plan. A Communications Strategy has been finalized, three editions of the newsletter produced and several other multi-media products that includes posters brochures, video, TV, and radio programmes are under different stages of production.

Outcome 2

The FCPF inception workshop was organized in March 2014 and the PEB provided approval for workplans and budgets for UN-REDD and FCPF in 2014 that are harmonized. A new REDD+ Technical Specialist, National Project Advisor, and, Project Assistant have been recruited.

FA, GDANCP, and FiA continue to implement field-based projects related to community forestry, protected areas, and mangrove forests to support the process of formulation of a draft National REDD+ Strategy. Two consultants have been recruited to guide the process of strategy formulation, and the draft is expected by the end of December, 2014.

A concept note on building on earlier work on Costs and Benefits has been developed and two national consultants are being recruited with technical assistance from WCMC and UNEP. The National meeting on assessment of existing benefit sharing distribution models used in Cambodia and in other countries was held in February 2014. These were followed by ten provincial consultative meetings and a technical paper on Safeguards is being finalized. An assessment of existing fund mechanisms has been undertaken and further work is being commissioned to refine this assessment for consideration of the Taskforce.

Outcome 3

Four meetings of the Demonstration Technical Team have been held and a study tour was organized for the Safeguards Technical Team to the Seima REDD+ pilot project in May 2014. The Wildlife

Conservation Society continues to implement site-based activities as the basis for learning lessons to be integrated into the National REDD+ Strategy.

Outcome 4

The MRV/REL technical team has been very active and has held on average two meetings per month. The members of the MRV/REL Technical Team (TT) participated in a GHG Inventory training to compare the advantages and disadvantages of the different IPCC guidelines; while Non-annex 1 countries are only obliged to report using the IPCC 1996 guidelines, the decision and request was made to use 2006 IPCC guidelines for GHG inventory training sessions on the Agriculture Forestry and Other Land Use (AFOLU) sector. As AFOLU includes the agriculture sector, the MRV/REL technical team members are exploring the possibility invite a member of the General Department of Agriculture as additional member to the MRV/REL TT. The period January to June 2014 covered many discussions and as the nominated members of the technical team have different levels of capacity and understanding of REDD+ components; it included a capacity building trajectory. During the period January to June 2014, the MRV technical team has agreed on the years to be used to assess historic emission development, and agreed on proposal for the forest (land use) definition to be submitted to the REDD+ taskforce. The new definition has been presented to the Taskforce. An initial REL is expected in the first half of 2015 following preparation of a roadmap by the end of 2014.

Methodical and operational consensus was reached between UN-REDD, the Forestry Administration (FA), the JICA technical advisory team (CAM-REDD) and the Forestry and Forest Products Research Institute of Japan (FFPRI) on production and improvement of existing maps jointly with the Forestry Administration (FA).

Following the National Forest Inventory (NFI) design proposal that has been presented December 2013, a field manual and inventory record sheets have been developed. The field manual has been tested in during two field trainings covering 6 different forest types in areas under responsibility of the relevant line agencies (FA, FiA, MoE). After the field practice the team received a training in the analysis and interpretation methods of the field data. Collected data used for the development of the NFI is undergoing further analyses to develop country specific biomass estimates and emission factors. A concept Note and Letter of Agreement to develop area specific allometric equations and emission factors for inundated forests have been prepared. An article on NFI Field manual development and training has been drafted and will be posted on the UN-REDD website.

A national workshop (FA, MOE, UN-REDD, USAID, JICA, FFPRI) was organized in March 2014 on Identifying Drivers of Deforestation and Forest Degradation in Cambodia. Subsequently a study on existing data of Drivers of Deforestation and Forest Degradation is being implemented. The draft has been produced and circulated with the relevant institutes, due to some requests for revision the completion of the report has been delayed and the follow-up study to quantify the key drivers of deforestation and forest degradation has been postponed until the third quarter.

Senior staff from the two implementing partners, FA and GDANCP, continue to provide leadership to the National REDD+ Taskforce. The implementing partners have also contributed staff time to Secretariat management, and to the four Technical Teams. REDD+ is increasingly reflected in discussions at all levels amongst the forestry institutions, including the National Forestry Programme

2010-2029. The FCPF project will contribute to sustaining the results achieved through UN-REDD. These are all indicators of sustainability in the forestry sector in Cambodia.

Comments by the Government Counterpart:

The period under reporting has implemented recommendations of the mid-term review and many national and provincial consultations, workshops, Technical Team meetings, and study tours have been organized. In addition concept notes and ToRs were finalized to initiate research and assessment of issues that would contribute to the REDD+ framework. A timeline of the National REDD+ Strategy document has been finalized and the first draft is expected to be ready by December 2014.

Demonstration activities in the field need to be strengthened and the MRV preparation requires an effective and revised work plan. The Taskforce will examine challenges related to these activities and take appropriate steps to ensure timely completion.

Comments by other stakeholders (non-government):

Consultation Group:

The Consultation Group (CG) consists of 18 members, representing 9 different non-governmental stakeholder groups, ranging from academic institutions, NGOs, and local community to private sector.

Representatives from the CG have been actively involved in a number of processes supported by the UN-REDD Programme. For example, one CSO and one Indigenous Peoples' representative sit on the Project Executive Board, giving them an opportunity to participate and contribute to decision making. Since early 2014, representatives from the CG have also participated actively in all four Technical Teams, established within the REDD+ Cambodia Programme with support from UN-REDD.

While the existing mechanisms give non-governmental stakeholders the opportunities to participate very actively in the development of REDD+ in Cambodia, members of the CG would like to stress two important issues.

Firstly, additional support, both finance and technical, is required to ensure that the CG is able to function effectively and to strengthen communication between CG members and their constituents, as the current arrangement does not well function. Secondly, the process of formulation of the National REDD+ Strategy has been initiated, it is particularly important that the CG and the stakeholder groups it represents are given ample opportunity to contribute to chapters of the Strategy and to comment on the drafts. This is particularly the case for sensitive topics such as Safeguards (including FPIC) and benefit distribution.

The CG welcomes new initiatives under the UN-REDD Programme to support active and effective stakeholder engagement, including the financial support for CG to function properly, the establishment of a gender team and the design of an intensive awareness raising programme for Indigenous Peoples and local communities. We encourage the UN-REDD to ensure these initiatives are pursued actively, and to extend the awareness raising to other grassroots groups such as community management networks. We also encourage the programme to ensure that the proposed new awareness raising materials such as videos and posters are produced and utilized as soon as possible. We humbly request that the UN-REDD to help intervene the

decisions and proposals proposed by the CG be taken into serious consideration by the Royal Government of Cambodia and concerned agencies for real and effective implementation. This action will ensure the continuation and proper function of CG in support to REDD+ programme in Cambodia if the CG is not considered as a nominal body.
