National REDD+ Awareness Raising Event and Launch of UN-REDD Support to Malawi

Cross Roads Hotel, Lilongwe, 29-30 April 2015

1. Introduction

As an active UN-REDD partner country, Malawi has embarked a comprehensive reform agenda and has developed a 5 year national action plan for REDD+, which outlines initial key actions to enable the country be prepared to implement REDD+ policies and measures.

Since its formal acceptation as a UN-REDD partner country in March 2014, Malawi has advanced its start-up phase of national REDD+ process with support of MNRP (Malawi National REDD+ Program) and requested the UN-REDD Programme to support specific element of the national REDD+ initiative. Building on the expertise of the UN-REDD agencies, namely the United Nations Development Programme (UNDP), the Food and Agriculture Organization of the United Nations (FAO) and the United Nations Environment Programme (UNEP), the Government of Malawi has designed two related capacity-building and scoping initiatives for the national REDD+ process, namely the Country Needs Assessment (CNA) and Targeted Support (TS).

2. Justification

The MNRP has made considerable strides over the past two years. Through the Malawi REDD+ Readiness Program (MRRP) and other efforts, the pursuit of REDD+ in Malawi has grown and evolved from a nascent, localized initiative to a national-scale program defined by a clear governance structure, work-plan, and vision. Malawi is now a UN-REDD partner country that has embarked on a number of regional REDD+ study tours, and has designated a National REDD+ Focal Point and an official REDD+ negotiation team to the United Nations Framework Conference on Climate Change (UNFCCC). Further, the MNRP has launched an ambitious effort to develop a zero-draft national REDD+ strategy, which requires further elaboration reinforcing essential building blocks.

In-country awareness and understanding of REDD+ under the UNFCCC and its implications for Malawi have grown in kind with the progress of the MNRP. Significant work remains in building proficiency in some of the finer details of the REDD+ mechanism and related concepts, primarily carbon financing and climate change. A concerted investment in the cultivation of such proficiencies – especially among a broader, in-country audience than the ones that have been targeted to date – is requisite for REDD+ to secure genuine, cross-sectoral traction and long-term viability in Malawi. A UN-REDD event would provide an opportunity for such an investment, offering an ideal platform to facilitate enhanced appreciation and knowledge of

REDD+ across targeted audiences. The onus would then be on the MNRP to build upon the gains of the event and carry them forward, recognizing that, over the long term, an intensive and concerted awareness-raising and education campaign is required. Further, the event would coincide with and inform the launch of a national-scale, REDD+ communication strategy.

3. Results

In order to launch the UN-REDD supported initiatives, it is envisaged to convene a national awareness—raising event that will also serve as the launch workshop for UN-REDD support to Malawi. Its major outcome is to consolidate ownership of key stakeholders for REDD+ in Malawi and UN-REDD supported activities.

To achieve this, the event will have the following **objectives**:

- to enhance understanding among wide range of stakeholders (government agencies, local authorities, NGOs, local communities and academia) of Malawi's engagement in REDD+
- 2) to inform and nurture high-level political commitment, including the range of opportunities and benefits that Malawi could potentially tap on from REDD+
- 3) to inform stakeholders the activities supported by the UN-REDD Programme (concept, timeline, implementation of different work streams under the proposed TS and CNA) and gather their initial feedback
- 4) to launch a national level community of practice on REDD+1

Key **products** resulting from the event will be an inception report and the results of a questionnaire filled during the event.

4. Proposed Agenda

The first day's agenda seeks to raise awareness and understanding of REDD+ among a target audience of Malawi's higher political tier and media; the second day seeks to cultivate proficiency in specific governance and scientific/technical aspects among a target audience of technical experts within Government of Malawi, academia, civil society, and the private sector.
