- c. Yemi will participate in mission. Other participation to be determined by results of discussion with Norway on the ToR. Need to think of whether the MPTF and RC have a role. (MG, 30 May)

- e. ToR will subsequently be shared with the Resident Coordinator and then the Government of VietNam (Yemi)
- f. Prepare response to Resident Coordinator following letter on modalities for communicating on REDD with VN (Yemi, 25 May)
