## 2. Progress with outreach plan to inform and consult in advance of PB9 on, principally Tier 2

- a. Secretariat to prepare paper on options outlining possible outcomes for Tier 2 decision as discussed during Geneva meeting and circulate for MG input. Will be shared with SG prior to Norway meetings (Secretariat to circulate by 28 Sept, Agencies to input).
- b. MG to brief respective SG members on options (MG, ahead of Oslo mission)
- c. Secretariat to recirculate relevant communications on Tier 2 sent to PB from the Secretariat (1 March & 15 May) (Secretariat, 28 September).
- d. Outreach matrix to be updated and recirculated to the MG (Secretariat)
