1. Approve minutes of previous MG call (22nd Aug)

a. Approved

2. Safeguards

- a. The proposed objectives and related considerations of the Programme's work on safeguards as described in the circulated concept note were endorsed. It was noted that UNDP/FAO/UNEP work on developing a harmonized approach to Social and Environmental Sustainability and Accountability, could possibly be incorporated in the future
- b. The preferred option for future working arrangements was 'Option 1', with the group established as a single, over-arching "Safeguards group", consisting of 2 persons per agency and coordination support from the Secretariat
- c. Any additional comments on the concept note will be incorporated by the group (Agencies to submit comments to the Safeguards group)
- d. Links to the forthcoming UN-REDD Programme International Workshop on Multiple Benefits were noted. It was agreed that the Safeguards group should liaise with the organisers, and that it will be essential to ensure the Agencies are sufficiently engaged (UNEP to share a draft agenda in due course)

3. Preparations for PB9

- a. Additional suggestions on the PB9 draft agenda will be addressed by the Secretariat, including comments submitted by Charles on gender issues and proposals to consider merging the sessions on Tier 2 and Targeted Support (Agencies to submit any comments to the Secretariat by cob 31 August)
- b. The draft roles and responsibilities document was welcomed. Additional offers of support will be incorporated, including Charles offer to support preparation for the Tier 2 session (*Agencies to submit any further comments by cob 31 August*).
- c. Secretariat will make some minor updates to the draft decisions document, including insertion of a decision on the external evaluation of the Programme, planned for 2013 (*Agencies to submit any initial comments by cob 31 August*)
- d. The three documents will be shared with the SG as draft versions (Secretariat)
- e. The draft agenda will be circulated to the PB to allow reaction by the PB on proposed items for discussion (Secretariat)
- f. Key elements from the 'Management Note' will be included in the PB Secretariat overview presentation, with the document made available for those who are interested (in EN, FR, SP). The Note will also be referred to during other relevant PB sessions (SNA session, discussion on the external evaluation, possibly during the discussions on the revised budget/workplan etc) (Secretariat to include in overview presentation, October 2012)

4. Update on events proposed/planned for COFO and Doha

Subject to any final comments from FAO on the concept note, it was agreed that the UN-REDD Programme should participate in the side event on *GREEN CARBON, BLACK TRADE,* including use of the logo on event publicity material etc. Involvement in the publication will be restricted to the contribution of the case study outlining UN-REDD Programme work on anti corruption and REDD+ (*Mette to provide comments to UNEP by cob 31 August*)

GP Budget and Workplan: Agencies to prepare budget priorities in order to facilitate Secretariat's work on the consolidated budget, along with the necessary background documents for PB (Secretariat to continue to liaise with donors to confirm the level of funding for 2012; WG to provide inputs to Secretariat by cob 31 August)
