Discussions -

- VRO will take on the role as data manager for AE data, which will in the future be integrated further into the government's forestry information system. As part of this responsibility, VRO has conducted a quality check of the field measurements carried out for AE development as introduced in the presentation. The results of the quality check have revealed the importance in steps of site selection (particularly with regards to the distance between plots), accuracy of tree species identification, and sample analysis. The field work and analysis done so far have followed the requirements outlined in the Guidelines developed, but still demonstrated the need for further care and consideration to make the data relevant. In the future, updating of the Guidelines will need to be done to ensure that improved data collection and analysis can be made.

Questions & discussions:

- The National Forest Inventory and Statistics program (NFIS) will be carried out during 2011-2015, based on the guideline which will be developed through the current piloting process. While the inventory work will be carried out largely by FIPI and its sub offices, the statistics component will be carried out through the provincial and local authorities.
- The reality of how each of the provinces will complete the statistics work (land demarcation) particularly in provinces where land allocation is largely at the

- household level, within the limited time and resources is questionable. Based on the Bac Kan experience, forest owner may be up to the commune level.
- There seems to be confusion and differences in the understanding of future implementation of NFIS; the presenter is of the understanding that this program will not be repeated directly following the 2011-2015 cycle, whereas, VNFOREST/VRO mentioned legal basis for continued implementation every 5 years.

• Based on the two preceding presentations, Vietnam will be generating forest inventory data on different scales for the next two inventory cycles (up till 2020). There should be more clarity on how the NFA work will take up the results from the preceding cycle, and the coherence between these two cycles. This also affects how provincially generated data (including that to be piloted in Dien Bien project) can be used for feeding into the national level (currently proposed as QA/QC data on annual basis).
