

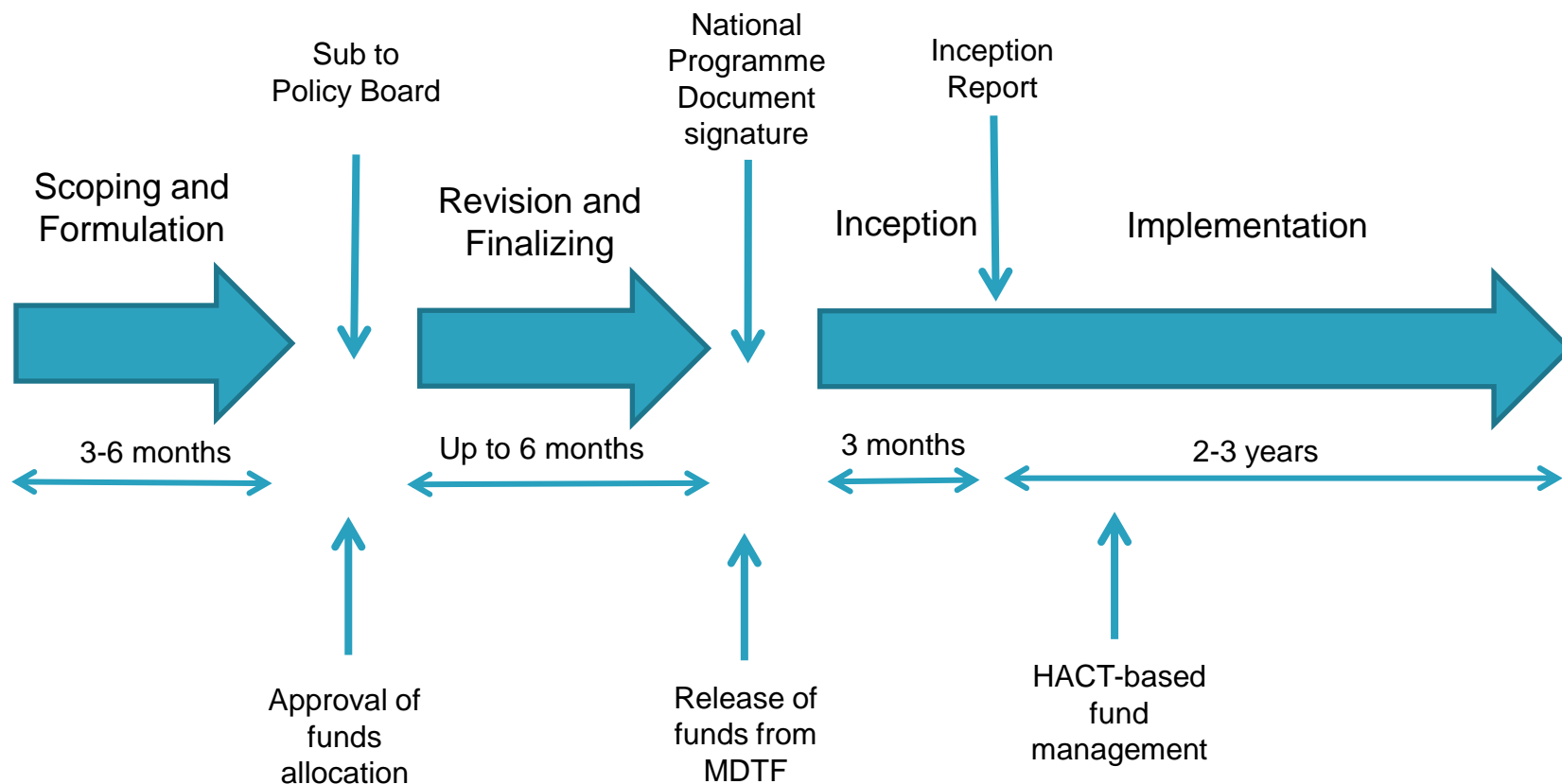

# National Programme Development Process



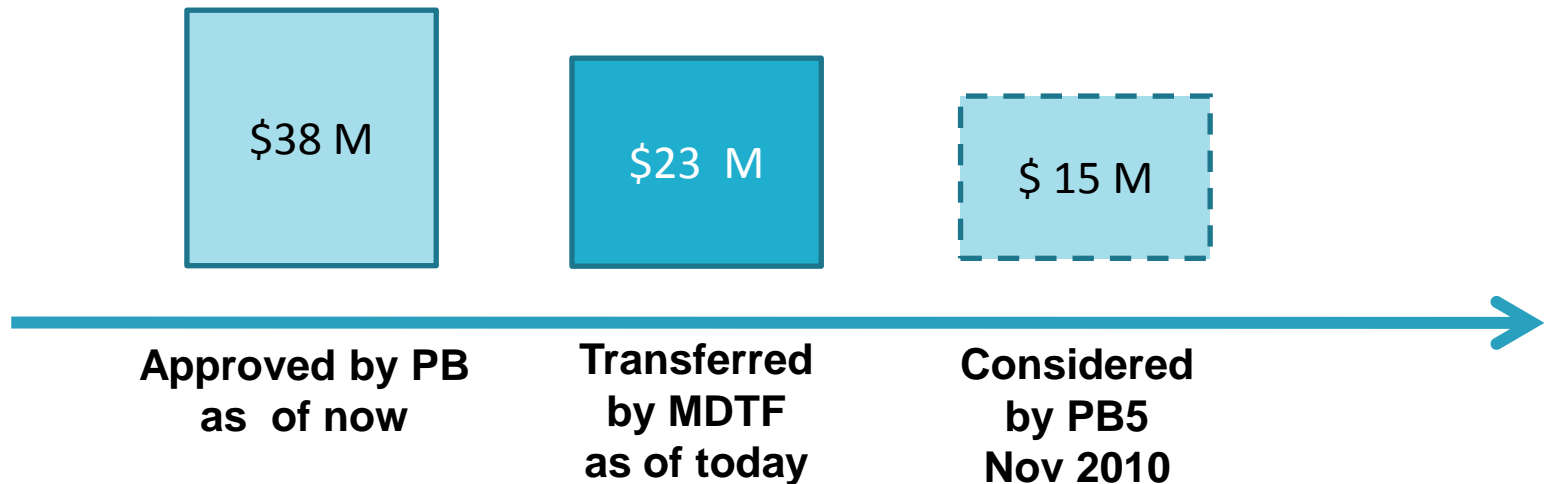

# Status of PB 4 NP approvals

- In March 2010 PB4 approved funding allocation requests from:
  - Bolivia
  - Zambia
  - DRC
- Six month rule: Deadline to receive signed NPDs approved in PB4 and before, September 21
- Zambia sent signed NP before deadline, funds disbursed already
- Bolivia, DRC, Panama, and PNG sent letters requesting extension of deadline
- Bolivia, DRC, and Panama signed their documents
- PNG submitted new Full NPD for consideration at PB5

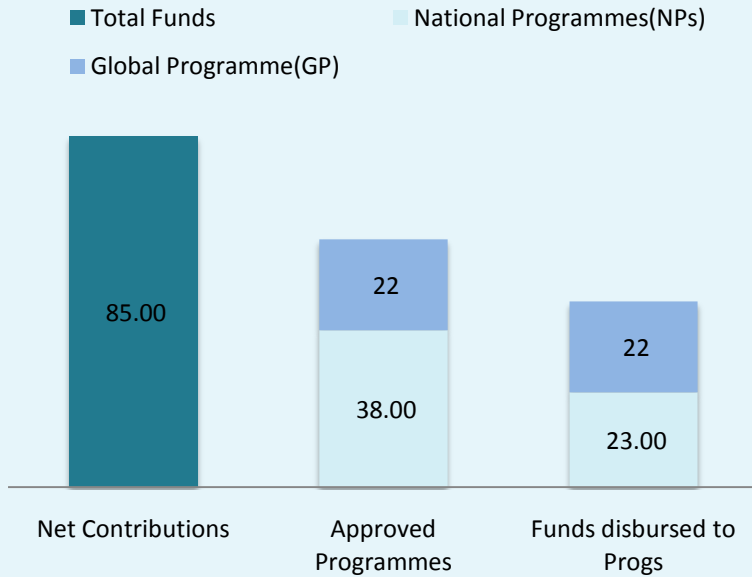

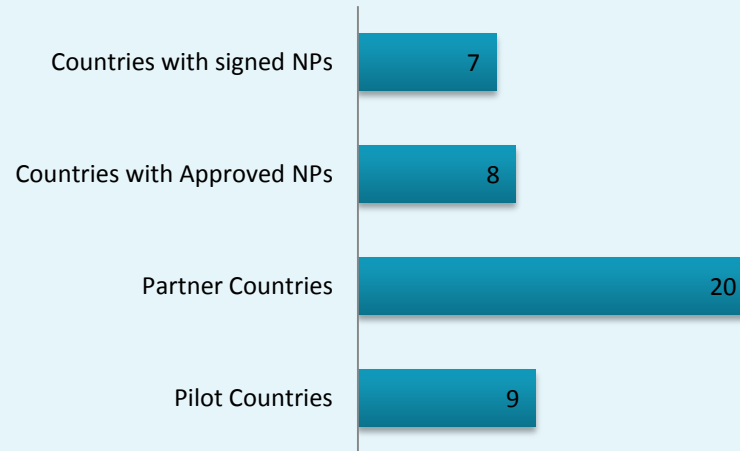

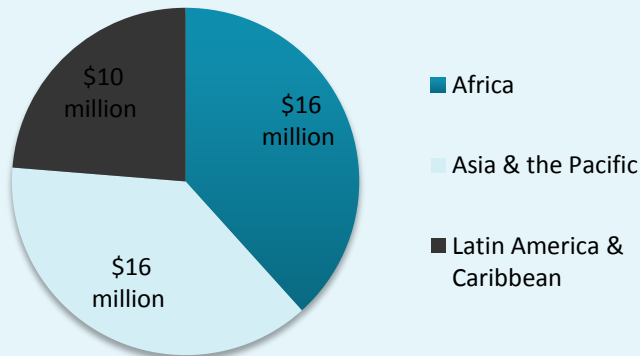
## UNREDD Financial Summary as at 1 November 2010 (\$US millions)



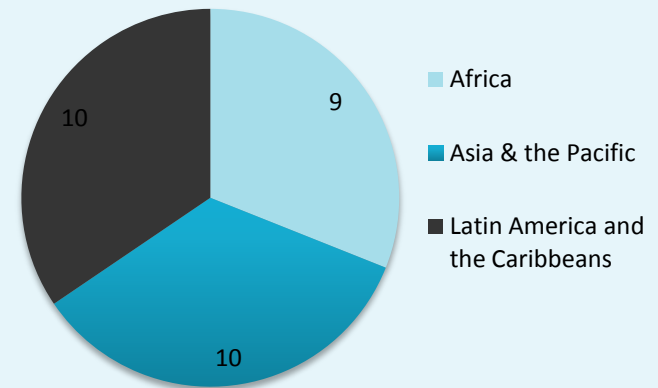
## UNREDD Country Participation
