CONTEXT

The REDD+ mechanism, which is part of the international climate-change policy negotiations (UNFCCC), is meant to promote and reward financially the conservation of forests under a *green development* path, in a simultaneous effort for climate change mitigation, ecosystem protection, community development and poverty reduction. The Federal Government of Nigeria is engaged in preparing for the REDD+ mechanism and is an active member of UN-REDD (a United Nations partnership to support countries on REDD+, constituted by FAO, UNDP and UNEP). Cross River State had catalysed this national interest in REDD+, building upon its record of community-based forest conservation, its efforts to build an interest in environmental finance as a means to counteract deforestation and to enhance rural livelihoods, and its political will to drive a pro-environment and people-friendly development process.

During 2010-2011, and in cooperation with UN agencies, Nigeria took the first, tangible steps towards REDD+. Accordingly, REDD+ coordination and consultation structures, both at Federal level and in Cross River State, were established. A comprehensive *Preliminary Assessment of the REDD Context in Nigeria*, as well as an exploratory study on the linkages between carbon, biodiversity & ecosystem services were elaborated. A number of UN-REDD support missions were conducted. All this led to the drafting and validation of the *Nigeria REDD+ Readiness Programme*, which was approved internationally by the UN-REDD Policy Board in October 2011, receiving positive reactions for its pragmatic and innovative approach, and being allocated with a budget of US\$ 4 million (around 650 million Naira). The *Nigeria REDD+ Readiness Programme* is based on a two-track approach that consists in basic REDD+ preparedness at national level and demonstrative REDD+ work at Cross River State (as model for the rest of the country).

OBJECTIVES

The **Nigeria REDD+ University** is an event intended to foster understanding and multi-stakeholder dialogue on REDD+ and to serve as public inception of *Nigeria's REDD+ Readiness Programme*. The event is scheduled for 19-21 March 2012 in Calabar, Cross River State (the pioneer state in Nigeria for REDD+). The UN-REDD Programme will provide technical & financial support. The objectives are as follows:

- (i) to enhance understanding on the REDD+ mechanism among Nigeria's stakeholders;
- (ii) to feed stakeholder engagement and dialogue around forest conservation and REDD+, with emphasis in Cross River State as leading state for REDD+ in Nigeria; *and*
- (iii) to stimulate preparatory discussions and arrangements for the implementation of the *Nigeria REDD+ Readiness Programme*, including options for expanding the scope of REDD+ to other States.

PARTICIPANTS

An audience of around 150 participants is expected. The Organising Committee will prepare the final list of participants, based on professionals and stakeholders that have so far participated in the REDD+ process plus others that have expressed interest, and ensuring a balanced representation of different stakeholder groups, including governmental officers (federal and state levels), NGO practitioners, community representatives, members of academia and the research community, members of advocacy groups, students, social and rural extension workers, journalists, and private sector entrepreneurs. Half of the participants are likely to come from Cross River State, and some participants will also be drawn from new potential REDD+ states. Particular attention will be given to the participation of the youth and community representatives, and for gender equality. A number of participants will be provided with lodging, as the budget allows.
