



Status of PB7 NP approvals and new request at PB8

- In October 2011 PB7 approved a funding allocation request from Nigeria (full NPD)
- Deadline to finalize and sign NPD: 13 April 2012
- The Republic of Congo and Sri Lanka will present their National Programmes for funding requests at this meeting
 - RPP documents, validation meeting requests and independent reviews posted in the web since March 12

Status of NPs in implementation

GRAMME

- Consolidated interim Annual Report and annexes for countries with NPs in implementation (Bolivia, Cambodia, DRC, Indonesia, Panama, PNG, Paraguay, Philippines, Solomon Islands, Tanzania, Vietnam, Zambia) provided in doc UNREDD/PB8/2012/II/1 and annexes
- Funds were transferred for Ecuador at the end of the reporting period, report to be presented in October
- Progress against planned results reported, and implementation challenges and lessons presented
- Agencies procedures analyzed to address implementation challenges



Working Group to support national programming efforts

- PB 6 established a WG to develop selection criteria, to pilot their application, and to propose priority countries to be invited develop new National Programmes
- The WG developed criteria and proposed prioritized countries that were approved by the PB inter-sessionally. Based on this, invitations to present NPs at PB7/PB8 were made
- In order to keep programming new National Programmes, the Board is now requested to:
 - Re-establish the WG
 - Request each PB constituency to self-select a representative to the WG and to inform the Board at the end of PB SN-REDD

- Improved guidance on MRV and Monitoring
 - Specific capacity building and knowledge transfer on the "national forest monitoring system" and on the "system to provide information on the REDD+ safeguards" with the Democratic Republic of Congo (DRC), Papua New Guinea and Viet Nam.
 - DRC and Papua New Guinea developed a beta version of the webbased information system and started the assessment of the historical changes in forest area.
 - In all partner countries that have National Programmes in implementation, with the exception of Bolivia, training activities on remote sensing (RS), national forest inventories (NFI) and MRV have been realized

- Improved guidance on MRV and Monitoring
- Targeted Support:
 - Support for monitoring and MRV implementation (DRC, Viet Nam, Indonesia, PNG, Panama, NFMS REDD+ DRC-PNG-Viet Nam-Ecuador, Zambia, Nigeria and Pacific Region).
 - Total: US\$ 567,480





OGRAMME

Increased engagement of stakeholders in the REDD+ agenda

- Draft UN-REDD Programme Guidelines for Free, Prior and Informed consent (FPIC) released for consultations.
- Joint UN-REDD-FCPF guidelines for stakeholders engagement submitted to external review and presented for public review.
- Terms of reference for a small grant system to support Indigenous Peoples and CSOs Policy Board members to reach out to and report back to constituents on the UN-REDD Programme activities.
- Support to Indigenous Peoples and CSOs participation in REDD+ in workshops and other REDD+ events.



ROGRAMME

- Increased engagement of stakeholders in the REDD+ agenda
- Targeted support and backstopping to NPs:
 - Support to engagement of relevant stakeholders in design and implementation of the REDD+ mechanism in the Yucatan peninsula (Mexico); to assessment of current key REDD+ capacity service providers in Asia-Pacific (Cambodia, Indonesia, the Philippines and Vietnam



ROGRAMME

- Increased engagement of stakeholders in the REDD+ agenda
- <u>Targeted support and backstopping support to NPs:</u>
 - Stakeholders engagement in the run up to the finalization of the national REDD+ strategy and the launch of the REDD+ investment phase in DRC; technical support missions to partner countries from HQ staff (Cambodia, Paraguay, PNG, Indonesia Zambia:
 - Total:US\$166,083



OGRAMME

- Improved analytical and technical framework of multiple benefits for REDD+ decision-makers
 - Social and Environmental Principles and Criteria developed, submitted to public consultations and finalized for submission to the UN-REDD Policy Board as voluntary guidance.
 - ArGIS mapping toolbox for multiple benefits analyses launched in December 2011 and guidance on mapping multiple benefits developed.



- Improved analytical and technical framework of multiple benefits for REDD+ decision-makers
- <u>Targeted support:</u>
 - Guidance on mapping the potential multiple benefits of REDD+ was tested in DRC; Technical Consultation on Social and Environmental Safeguards for REDD+ was held in Nigeria; Initial consultations in Indonesia on multiple benefits work and further work on toolkit development; Multiple benefits work on mangroves (DRC, Cameroon, Gabon, Republic of Congo);

ROGRAMME

- Improved analytical and technical framework of multiple benefits for REDD+ decision-makers
- <u>Targeted support:</u>
- support to multiple benefits publication in Ecuador; multiple benefits work on mangroves (DRC, Gabon, Cameroon, Republic of Congo); technical support towards the development of national REDD standards in DRC.
- Total: US\$ 251,692



- Knowledge management, coordination and communication
 - NPs Handbook concluded and submitted.
 - NPs planning, monitoring and reporting framework developed
 - Support to National REDD+ Actions Global Programme
 Framework Document developed and approved.
 - Internal Review of the UN-REDD Programme commissioned and concluded.
 - UN-REDD publications delivered, including the Asia-Pacific lessons learned booklet and the Policy Brief on REDD+ and the green economy.

- Knowledge management, coordination and communication
- <u>Targeted support and backstopping to NPs:</u>
 - Technical review support to NP (Cambodia, Paraguay, PNG, Nigeria and Ecuador; Policy and technical support from RTAs, including in-country missions, in Asia-Pacific, Africa and Latin America; Technical support missions from headquarter staff to Indonesia and Guyana.
 - Total: US\$ 380,067.

- Increased transparency and effectiveness in national REDD+ governance
 - "Draft Guidance for the Provision of Information on REDD+ Governance" developed by the UN-REDD Programme and Chatham House, and the "Framework for Assessing and Monitoring Forest Governance" delivered.
 - Participatory Governance Assessments (PGA) for REDD+ launched



- Increased transparency and effectiveness in national REDD+ governance
- <u>Targeted support:</u>
 - Support to Nigeria and Indonesia PGAs:
 - Total: US\$ 60,000

- Development of equitable benefit-sharing
 - Progress in the design of benefit distribution system (BDS) notable in several countries in Asia, including Viet Nam, Indonesia and Cambodia.
 - Progress in anti-corruption capacity building and programming in UN-REDD partner countries.
 - Report "Business Case for Mainstreaming Gender in REDD+" and a supplementary guidance note distributed at the Durban UNFCCC COP-17



ROGRAMME

- Support to low carbon-sector transformation
 - Report "Business Case for Mainstreaming Gender in REDD+" and a supplementary guidance note distributed at the Durban UNFCCC COP-17
 - Partnerships to promote transformation through green economy in DRC established.
 - Engagement of legislators and financial institutions in the process of transformation to the green economy promoted.



- Support to low carbon-sector transformation
- <u>Targeted support</u>:
 - Support to work related to transformation in DRC in partnership with CIRAD; Support Indonesia in its efforts towards a green economy transition in Kalimantan; Support to participatory scenario analysis methodologies and multi criteria decision models for a REDD+ transition to a green economy in DRC and Ecuador:
 - Total: US\$ 272,585

- Targeted Support and backstopping to NPs in 2010-2011
- Total: US\$1,697,907
- From 2012:
 - Adoption of clear procedures for requesting targeted support.
 - Registry of targeted support by the Secretariat.
 - Reporting on targeted support and backstopping to NPs.

Secretariat Budget

- A process is underway to integrate the Secretariat element of the Global Programme budget into the overall GP budget
- Integration to take account of evolution of the UN-REDD Programme
- Consequently, the Secretariat proposes to present an inter-sessional funding request covering a period of 4 months (July-Oct), for the Policy Boards consideration
