







## Note for the Policy Board on the process followed for preparing Tier 2 Terms of Reference

**UN-REDD PROGRAMME** 

30 April 2012

## 1. Background

In 2010 the Policy Board endorsed the UN-REDD Programme Strategy (2011-15). The Strategy identified creation of a new financial modality, "Tier 2", as one of its key elements. Further, under the section on Resource Mobilization, the strategy defines Tier 2, the role of the agencies in the process, and reporting to the Policy Board. The "Tier 2", as defined by the UN-REDD Strategy, incorporates to the UN-REDD Programme REDD+ activities undertaken by the UN participating agencies that are clearly contributing to the overall Programme Strategy and which are funded through various sources. The ultimate purpose of Tier 2 is to provide an opportunity to UN-REDD Programme partner countries to benefit from the UN-REDD agencies expertise, and from the synergies promoted by the "delivering as one concept", in funding arrangements between the country and donors.

"Tier 2" was further considered at subsequent Policy Boards (see table 1 for references). The Seventh Policy Board meeting requested the UN-REDD Programme Secretariat to share the Terms of Reference for Tier 2 funding with its members, which were duly circulated on 1 March 2012 (provided at Annex 1). At the Eighth Policy Board, the Board requested the Secretariat to recirculate the Tier 2 Terms of Reference to the Policy Board members for comments, along with a review of the procedures adopted to develop and share the Tier 2 Terms of Reference. This note summarizes the process followed.

## 2. Process for developing the Tier 2 modality

- In 2010 the Policy Board endorsed the UN-REDD Programme Strategy (2011-15) after requesting
  certain amendments be made including that the Policy Board is informed of Tier 2 decisions. The
  Strategy defines Tier 2, the role of the agencies in the process, and reporting to the Policy Board.
  The Strategy states the following about Tier2 activities:
  - Funded through sources other than the UN-REDD Programme fund.
  - Tier 2 activities are undertaken jointly or individually by agencies but clearly contribute to the overall UN-REDD Programme as defined in the Programme Strategy
  - Approved by the UN-REDD Programme CG involving all agencies. The CG approves
    the UN-REDD Programme affiliation before any formal proposal is submitted to a
    donor(s).
  - All tier 2 activities will be implemented preferably through joint programmes and can include both national and global activities.

- Progress reports on Tier 2 activities will be submitted to the Policy Board.
- 2. The endorsement of the Strategy includes arrangements for the Tier 2 mechanism and the role of the agencies.
- 3. The Tier 2 mechanism is consistent with the general funding framework of the UN-REDD Programme, in addition to the funds channeled to the Multi Partner Trust Fund (MPTF).
- 4. At the Sixth Policy Board, the Board requested that options such as Tier 2 be explored as a means to raise additional funding for National Programmes. This decision clearly acknowledges the previous endorsement of the Tier 2 mechanism and the Board encouraged the Programme to explore options to utilize the Tier 2 mechanism.
- 5. At the Seventh Policy Board the Board stated it "was pleased to note the development of Tier 2 as an important funding window and an attractive mechanism for donors and recipient countries".
- 6. On March 1 2012 the Secretariat circulated the Tier 2 ToR to all Policy Board members and during the Eighth Policy Board informed the members that the ToR was circulated. No comments were received prior to and during the progress report by the Secretariat at the Policy Board meeting. At the closing session of the meeting, one Policy Board member asked for clarifications on the procedures followed to develop the Tier 2 ToR and the following decision was taken:
  - (i) to re-circulate the Tier 2 Terms of Reference for comments to the Policy Board members; and (ii) the Secretariat to circulate a review of the procedures adopted to develop and share the Tier 2 Terms of Reference.
  - a. Following up (i) and (ii) above, the Secretariat will circulate an updating note consolidating comments received and advising the Board on possible next steps.
  - b. The Board requests an information session on Tier 2 to be held at the ninth Policy Board meeting.

Dear All,

As you may recall, in 2010 at the Fifth Policy Board meeting the Board endorsed the UN-REDD Programme Strategy 2011-2015. The strategy identified the creation of a new financial modality, "Tier 2", as one of its key elements, which will include REDD+ activities undertaken by countries and supported by the UN-REDD Programme agencies that are clearly contributing to the overall UN-REDD Programme Strategy and which are funded through various sources. Further, under the section on Resource Mobilization, the strategy defines Tier 2, the role of the agencies in the process, and reporting to the Policy Board.

This issue has been further considered at Policy Boards. Most recently, the Seventh Policy Board meeting requested the UN-REDD Programme Secretariat to share the Terms of Reference (ToR) for Tier 2 funding with its members. Correspondingly, I am pleased to circulate the approved Tier 2 ToR for your information. To access the document (via the Programme workspace) click on the following link:

The ToR emphasise that the Tier 2 modality will be responsive to country context and needs, and that the governance and quality of Tier 2 activities will be consistent with the UN-REDD Programme strategy and quality, principles, standards and safeguards. The modality will enable Governments to access UN-REDD technical support by submitting Tier 2 proposals.

Tier 2 will play an important role in building on the solid foundations of the work that has started on initial readiness by providing an opportunity for countries to expand readiness activities. In countries that have made progress with initial readiness it offers an opportunity to scale up.

Tier 2 provides greater flexibility in terms of funding options using funds beyond the UN-REDD Programme Fund. As agreed at Policy Board 5, Tier 2 activities will be reported to the Policy Board for information.
