	Programme Brief description	Deforestation and forest degradation comprise a large proportion (approximately one fifth) of global anthropogenic greenhouse emissions. The United Nations Framework Convention on Climate Change (UNFCCC) has adopted the REDD+ mechanism i Cancun agreements. The development is now on its way to provide financial incentives for the reduction of such emissions. Ri includes Reducing Emissions from Deforestation and Forest Degradation (initially referred to as REDD) as well as: i) conservatiforests; ii) sustainable management of forests; and iii) the enhancement of forest carbon stocks.  The primary drivers of deforestation and forest degradation need to be addressed in order to ensure the success of National RE programme. In Zambia, these drivers vary across regions and include inter alia: i) charcoal and wood fuel use (for dom commercial and industrial uses); ii) timber production; and iii) unsustainable agricultural methods and other land use practices. Drof deforestation and forest degradation are a result of a complex set of underlying causes that are primarily caused by past and cut development processes. These underlying causes cut across numerous sectors (e.g. energy, forestry, agriculture, land and wate order to address them and thereby to facilitate the realisation of REDD+, the entire mode of development within Zambia will need altered. Both the supply and demand for wood and non-wood forest products will, for example, need to be addressed simultaneous programme Goal: To prepare Zambian institutions and stakeholders for effective nationwide implementation of the REDD+ mechanism. a) As part of raising awareness, presentations were made at various meeting including at the UNZA student Environmental Association, Community Based Natural resource Management Forum annual review meeting, Zambia National Climate Change Network. A Civil Society consultative meeting was held on the 5<sup>th</sup> October at Kingfisher Hotel and Resorts. The meeting aimed at identifying civil society representatives in the REDD+ readiness process.

#### Outcome 3

The Strategy framework was not prepared as it is dependent on the outcome of the consultancies on Drivers of Deforestation, Stakeholder Analysis and Forest Management best Practices

#### Outcome 4

The Consultancy on Drivers of Deforestation and Potential for REDD+ in Zambia was advertised and recruited. The Copperbelt University was selected to undertake the assignment.

#### Outcome 5

- Three short term consultancy have been recruited to undertake the following assisgment:
  - Consolidate and document forestry research publications, past forest management plans and reports
  - b) Consolidate digital information of forest, agriculture, energy
  - c) Identify GIS requirements for Provinces
  - d) Basic REDD training Manual

## Challenges

- 1. **Attachment of Staff:** The three members of staff attached to the programme were officially attached to the programme and this is expected to enhance the operations of the Coordination Unit.
- Delay in the establishment of the Steering Committee and Multi-sectoral committee. The Ministry has been abolished
  and this has affected the process of formalization of the Joint Steering Committeee. However, appointments of Focal point
  persons from key institutions like Agriculture, Energy, Finance, local government and Community Development has been
  processed.
- 3. **Linkages and coordination among UN-REDD, ILUA, CCFU and ENRMMP:** The Ministry prepared a Concept on the harmonization/integration of the four (4) programmes. However, the senior management had not yet approved the concept by the end of third quarter.
- 4. It must be noted that the Ministry has been abolished and the function have been split between Ministry of Information, Broadcasting and Tourism, and that of Ministry of Local Government, Housing, Early Child Education and Environmental Protection. This may result in some adjustments in administration of programmes in the Ministry.
