

Sub-National Awareness Raising Workshop Concept Note

“An introduction to the Concept of Reducing Emissions from Deforestation and Forest Degradation – REDD+”

Introduction

Timely awareness raising to all identified stakeholders is a vital part of ensuring transparency in the REDD+ Readiness process. RECOFTC Cambodia Country Program along with the Cambodia REDD+ Taskforce Secretariat is conducting a REDD+ Awareness Raising project at both the National and Sub-National level to identified key stakeholder groups which include, Government, Academia, Civil Society Organizations, National and International NGOs, Communities (Community Forestry, Community Fisheries, and Community Protected Areas) and Indigenous Peoples. An Awareness Raising Training Event on “*An introduction to the Concept of Reducing Emissions from Deforestation and Forest Degradation – REDD+*” took place the 16-19 December 2013 at the National level for members of the REDD+ Consultation Group, subsequently 12 sub-national Awareness Raising Workshops have been planned in 6 selected target provinces.

Workshop objectives

The specific objectives of the workshop are:

- To share the most updated information about REDD+ to targeted stakeholders at the sub-national level.
- For participants to understand the National REDD+ Framework and Implementation process

Framework

The workshops will be held over the course of one (1) day, there will be 12 workshops in total, two in each of the 6 target provinces: Mondulkiri, Stung Treng, Preah Vihear, Kampong Thom, Kratie, and Koh Kong.

Participants

Each workshop will take place over 1 day and will be conducted twice in all 6 provinces for 2 different groups;

Group 1 – Provincial/local government authorities (FA, Fai, MoE, Mol, etc..) and CSOs (approximately 25 participants in each workshop)

Group 2 - CF, CPA, CFI and IP representatives (approximately 25 participants in each workshop)

Participant selection

The selection of participants will be undertaken in co-ordination with RECOFTC, the REDD+ Consultation Group (inclusive of the sub-national training facilitators), the REDD+ Taskforce Secretariat and RECOFTC provincial partners (provincial NGOs, FA Cantonment) using the list of stakeholders identified by the Voluntary Facilitation Committee and identified by participants during the National Training event on *“An introduction to the Concept of Reducing Emissions from Deforestation and Forest Degradation”* as a basis for participant selection (Please see Annex 1 for tentative list of participants). Once the lists have been finalized they will be sent for the approval of the REDD+ Taskforce.

Facilitators

After the National level training event on *“An introduction to the Concept of Reducing Emissions from Deforestation and Forest Degradation – REDD+”* (conducted 16-19 December 2013) participants, who included REDD+ Consultation group members, FA staff, MoE staff, FiA staff, and community members, were asked to volunteer to facilitate the sub-national REDD+awareness raising workshops. This pool of volunteers from the workshop was then discussed with the REDD+ Taskforce Secretariat and REDD+ Taskforce and new facilitators were suggested based on known past experience and to ensure that a central pool of 10 trainers were based in Phnom Penh and could be involved further in the Awareness Raising process over the coming years. The final list of the 10 trainers can be seen below.

Based on the evaluation feedback from the training event at the National level, it was found that participants responded to nesting the introduction of REDD+ within the context of climate change and deforestation in Cambodia, this enabled participants to better understand REDD+, its evolution and future implementation, therefore this concept will be retained in the sub-national workshops.
