RED, REDD, REDD+

- UNFCCC is developing a mechanism to create an incentive for developing countries to protect, better manage and wisely use their forest resources, contributing to the global fight against climate change.
- Reducing Emissions from Deforestation and Forest Degradation.
- "+" covers the role of conservation, sustainable management of forests and enhancement of forest carbon stocks in reducing emissions.





An international mechanism initiated by the UNFCCC

•UNFCCC is the international initiative to reduce climate change

•Designing a REDD+ mechanism where countries with standing forests are incentivised to maintain their forest cover

•REDD+ under the UNFCCC will be results-based - main objective being emissions reduction, not development



United Nations Framework Convention on Climate Change



Example REDD+ actions under the five UNFCCC REDD+ activities

Reducing emissions from deforestation

Reduce agricultural incursion in an area of natural forest through creation of alternative livelihoods

Reducing emissions from degradation

Provide woodlots close to villages to reduce the need for firewood collection

Conservation of forest carbon stocks

Designate new national park

Sustainable management of forests

Introduce a policy that logging concessions create reduced impact logging management plans

Enhancement of forest carbon stocks

Restore a degraded forest through the planting of native species











What are the Multiple Benefits of REDD+?



- When forests are retained or restored through REDD+, they deliver additional benefits to protecting or enhancing carbon stocks.
- All benefits from REDD+, including mitigating climate change, are referred to as "multiple benefits"
- Types of benefits from REDD+:
 - Biodiversity conservation
 - Ecosystem services
 - Livelihoods and social well-being



UN-REDD What are multiple benefits from REDD+?



- Cancun safeguards agreed by Parties to UNFCCC, they aim to guard against harm from REDD+ and enhance benefits
- Social and environmental benefits should result from successful application of the Cancun safeguards




