# 1. Background

The First FCPF Evaluation Report made recommendations for: (i) enhancing support for indigenous peoples' (IPs) engagement in REDD+ and (ii) creating a new capacity building program to support the engagement of southern CSOs

- Action Plan adopted after the global dialogue with IPs on the FCPF included a proposal to expand the existing capacity building program
- The PC subsequently increased the Forest-Dependent Peoples' program by \$3.5 million for fiscal years (FY) 2012-2015
- PC also allocated \$2 million for FY 2012-2015 capacity building program for Southern CSOs
- Subject to FMT presenting the results of a mapping exercise of comparable activities supported by UN-REDD, FIP, FCPF

# 2. Results of the Mapping Exercise

### (i) Participation in Meetings

All three programs provide travel support to IPs and CSO representatives to participate in governance meetings:

- FCPF supports participation in Participants Assembly and Participants Committee
- UN-REDD supports participation in Policy Board meetings
- FCPF and the UN-REDD also provide funds for IPs and CSO actors to participate in other relevant regional and international REDD+ events
- FIP supports participation in Sub-Committee meetings

## 2. Results of the Mapping Exercise Cont.

#### (ii) Consultation and Participation in REDD+ Processes

All three programs are supporting national, regional and global level consultations with IPs, forest-dependent peoples and CSOs

- FCPF will support three Regional Dialogues and one Global Dialogue (2012-2013) with IPs on the FCPF
- The UN-REDD Programme supports consultations on the development of key components of UN-REDD National Programmes and consultations to support the implementation of national actions
- FIP has supported regional and global consultations to design the \$50 million Dedicated Grant Mechanism (DGM) for Indigenous Peoples and Local Communities – further consultations planned for 2012

### 2. Results of the Mapping Exercise Cont.

#### (iii) Capacity Building Programs

Capacity building activities for all 3 programs focus on REDD+ related issues, e.g., land tenure, governance, participatory monitoring, livelihoods, safeguards, benefit sharing, indigenous knowledge systems, etc.

- FCPF capacity building program for IPs capacity building and engagement [funds of \$3.5 million over 3 years]; capacity building and engagement program for Southern CSOs [\$2 million over 3 years]
- UN-REDD supports capacity building of IPs &CSOs to participate in REDD+ processes: funding for the IP/CSO Policy Board representatives; support to countries and regional activities; development of guidance
- FIP DGM will focus on capacity development and engagement of IPs and local communities in REDD+ [funding of up to US \$50 million for 8 pilot countries; \$5 million for global component]

## 3. FCPF Capacity Building Programme Advisory Committee

#### **Coordination Mechanisms:**

- Global Advisory Committee(s) for the FCPF Capacity Building Program will be created with representation from:
  - Two IP representatives from Africa, Latin America, Asia and one IP representative from the Pacific region
  - Two representatives of the PC
  - Two representatives from the FMT
- Same configurations is also proposed for the CSO program

The Advisory Committee(s) could provide coordination functions with other capacity building programs, hence increasing synergy across various initiatives. In addition, representatives from the UN-REDD Programme, and FIP's DGM could be invited to attend meetings of the Advisory Committee(s)

## 3. FCPF Capacity Building Programme Advisory Committee

#### Role of the Advisory Committee:

- The Advisory Committee(s) would make recommendations on the allocation of funding from the FCPF capacity building programs by:
  - Setting priorities and requesting proposals
  - Reviewing proposals
  - Recommending which ones should get funded
  - Specific selection criteria would be adopted in due course

### 4. Collaboration between FCPF, UN-REDD, FIP

- Joint R-PP Template
- Joint FCPF/UN-REDD Stakeholder Engagement Guidelines
- Joint Country Activities UN-REDD/FCPF missions (e.g. DRC, Republic Of Congo, Indonesia, Vietnam); Joint FCPF/FIP missions (e.g. DRC, Ghana, Indonesia)
- Collaboration on Regional and Global Consultations e.g., regional FPIC consultation; Global/regional IPs dialogues; FIP regional caucuses
- Coordination with Relevant Initiatives UN-REDD and FIP Participation on the FCPF Advisory Committee; Building on existing mechanisms (e.g. UNDP/GEF Small Grants Programme which provides grants for IP & local communities in 122 countries)
