Origins of UN-REDD

- All 3 agencies involved in REDD from before 2007
UNFCCC COP in Bali
- Carved out UN's niche in REDD in response to opportunities
 - social & environment benefits, governance, MRV, engagement of stakeholders, benefit sharing
- Initial legal basis: the MoU & Framework Document
 - Pass-through considered “best practice”
- Now recognised as one of two major multilaterals

Timeline and milestones

September 2008

Launch with Norway's Prime Minister , SG and Heads of Agencies

9 pilot countries

June 2008
MoU signed

June 2009
Secretariat established in Geneva

March 2009

First Policy Board meeting :

- Rules of procedure established
- First 4 national programmes approved
- Inclusive governance structure of the PB established
- Knowledge platform launched

May 2010
Agreement that UN-REDD and WB provide joint Secretariat services to the REDD+ Partnership

November 2010
UN-REDD Strategy endorsed

- 6 work areas
- Set out new modalities for support

- Global Programme 2011-2013 approved

↳ Grew from


- a collaboration among a small group of colleagues to a flagship initiative of the 3 agencies, recognised by the UN Secretary General as best practice of One UN




Donor Contributions to the MPTF





National Programme Achievements

- UN-REDD is delivering financial and technical support at the country level
- Despite delays in some countries, others such as DRC, Viet Nam and Indonesia have made significant progress (and are moving to phase 2)
- Through National Programmes, countries are leading and innovating in key technical aspects of REDD+ readiness
 - developing monitoring and MRV systems
 - designing and piloting benefit distribution systems
 - piloting FPIC
 - building strong governance frameworks

Global Programme

- Contributes
 - to countries' understanding of the technical aspects of REDD+
 - to clarifying and harmonizing the range of approaches and methodologies for REDD+ implementation
- Offers support through
 1. Normative guidance and tools
 2. Policy Board support and Secretariat functions
 3. Technical and policy advisory services to countries, including regional teams

Global Programme Achievements

- Developing and disseminating guidelines and tools (multiple benefits, safeguards, stakeholder engagement, MRV and monitoring, governance)
 - ↳ Put these issues on the map and contributed to their uptake by countries
- Capacity building through 30 consultations and events over 3 years
- Concrete and valued technical support (MRV, stakeholder engagement, etc)
- Gained respect and trust of civil society and Indigenous Peoples
- Good examples of inter-agency work, especially in regional teams

The Current Context for REDD+

- International negotiations have moved slower than expected
- An international architecture to support REDD+ crediting is unlikely in the near term
- In particular, developed countries have not created demand for scaled-up REDD+ financing
- Yet..
 - Some demand emerging (e.g. bilateral REDD+ mechanisms, domestic markets, revenues from auctioned allowances, emerging cap and trade systems)
 - Countries recognizing the “win-win” that REDD+ provides

Why these countries?

- 9 pilot countries selected through 8 criteria:
 1. Expressed willingness for Quick Start action
 2. Collaboration between country/UN/ other actors
 3. Emission avoidance potential
 4. Degree of REDD readiness potential
 5. Regional, biome and socio-economic representation
 6. Coordination with international REDD initiatives
 7. Potential to provide leadership in sub-regional sharing of experience
 8. Ability to contribute experiences to UNFCCC negotiations/development of REDD mechanisms
- In 2011 Criteria were refined and applied to select the new countries reduced to:
 1. Contribution of UN-REDD to the national readiness
 2. Effective engagement of UN agencies at a country level
 3. REDD+ potential
