







# Workshop to establish a REDD+ Roadmap Taskforce in Mongolia

## **Workshop report**

Held at: Bayangol Hotel, Ulaanbaatar, Mongolia
13 September 2011

## **Purpose of Workshop**

At the invitation of the Forestry Agency of the Ministry of Nature, Environment and Tourism (MNET) in Mongolia, a workshop to discuss a proposal to establish a REDD+ Roadmap Taskforce was held in Ulaanbaatar, Mongolia on 13 September 2011. The workshop was conducted jointly by the Forestry Agency, the UNDP Country Office, Mongolia, and the UN REDD Programme / UNDP Asia-Pacific Regional Centre.

## **Workshop objectives**

The objectives of the workshop were:

- To raise awareness of REDD+ among key stakeholders in Mongolia;
- To inform participants of the role of the UN REDD Programme; and
- To discuss the proposal by the Forestry Agency to establish a REDD+ Roadmap
   Taskforce in Mongolia, and to obtain feedback on the proposal.

## **Participants**

A broad range of stakeholders from government, civil society, donors and development partners (including Forest User Groups, local governments, and the private sector) were invited to attend the workshop, with 49 invitees actually attending on the day.

**Annex A** contains a list of workshop invitees and attendees.

## **Summary of workshop**

The Director of the Forestry Agency, Ms Tungalag, opened the workshop, welcoming participants and indicating Mongolia's interest in developing a plan for Mongolia to engage with the emerging international REDD+ mechanism. Mr Thomas Eriksson, the UNDP Deputy Resident Representative then addressed participants, emphasising the importance of taking action to mitigate and adapt to climate change and confirming UNDP's commitment to assisting Mongolia with the REDD+ readiness process.

#### **Presentations on REDD+**

The morning session focussed on raising awareness of REDD+, with presentations from Ms Lisa Ogle, a UNDP / UN REDD Programme consultant, on 'What is REDD+?', and 'The international legal framework for REDD+'. Mr Akihito Kono, the UN REDD Regional Technical Advisor based in Bangkok, gave a presentation on the role of the UN REDD Programme. This session also identified the requirements for REDD+ readiness and the role that a Roadmap plays in identifying a country plan for REDD+ readiness.

## **Observations of REDD+ from participants**

Following the presentations and before lunch, participants were invited to provide feedback on the morning's presentations, and to indicate how they thought REDD+ might be relevant to their work and their communities.

Questions and statements were made by participants relating to:

- Whether Mongolia's Green Wall Programme could be included in REDD+? (comment from Director of Green Wall Programme)
- Whether local communities could be paid directly for their work in reducing emissions from their forests?
- The possibility of herders using biofuels and therefore reducing their reliance on fuel wood from forests, and the need for MNET to work with herders on this issue (comment from herder/ Forest User Groups)
- The need for more active forest management through better forest management plans, which would assist with addressing forest degradation (comment from Selenge aimag)
- The need for better land use planning to delineate areas for agriculture (crop production) and for forestry (comment made by MFALI)
- The need to change policies relating to forest cleaning to allow local communities to extract old or diseased wood from forest areas and Special Protected Areas (comment from community group in Khentii aimag)

- The importance of trying to use REDD+ to assist with efforts to combat desertification
- The importance of addressing corruption where government people are involved
- The need to improve standards for the collection of wood fuel
- The process should consider using existing results and lessons from various government programmes
- There is a difference between the forest definitions that the Forestry Agency uses and those used by FAO, resulting in a data discrepancy.

## Proposal by Forest Agency Director to establish REDD+ Taskforce

The afternoon session focussed on the process for establishing a REDD+ Roadmap Taskforce in Mongolia. The Director of the Forest Agency introduced participants to the provisions of a draft Ministerial decree by the Minister for Nature, Environment and Tourism to establish a REDD+ Roadmap Taskforce. The taskforce membership was discussed by all participants. Participants then broke into three working groups to consider particular elements of the proposed Roadmap.

The Director of the Forest Agency proposed the following initial list of 15 Taskforce members:

The proposal included nominating the Director the Forest Agency as Chair and the Forest Agency as Secretary.

Various comments were made by participants in response to this proposal including:

- Suggestions that additional people be added to the Taskforce, including:
   representatives from local communities (although it was acknowledged that this
   might involve difficulties in attendance due to distance and travel and it was also
   noted by the Director of the Forest Agency that they do not have a unified
   organisation representing these communities); a representative from the CDM; a
   representative from the business sector; a representative from community forest
   partnerships (as these are not represented by the Mongolian Environmental Civil
   Council); a suggestion that the environment units of aimags could represent local
   communities; a representative from emergency management for forest fire issues;
   the Rangeland Pasture Management Association (suggested by ADB);
- The importance of the Taskforce engaging in regional and local consultations on the proposal to engage with REDD+
- A request for a glossary of REDD+ terminology for Taskforce members.

Following this discussion, the Director agreed to consider all of these suggestions and to propose to the Minister that three additional members be added to the Taskforce.

Workshop participants then divided into three working groups, using a process of self-selection, to discuss the following topics:

- Working group 1: Drives and strategies
- Working group 2: Stakeholder engagement and safeguards
- Working group 3: Reference levels and MRV

After discussion within groups, a representative from each working group reported back to the plenary.

## **Closure of workshop**

Ms Ogle (Consultant UN REDD/ UNDP) noted that the Taskforce would be asked to prepare material through working groups for the Roadmap, and that there would be a further mission and national level workshop held in November 2011 to review the work of the Working Groups and to identify the next steps required. There may also be a regional consultation held in November 2011 in Selenge Aimag.

The Director of the Forest Agency noted that there was much work to do to develop a REDD+ programme in Mongolia and undertook to have the REDD+ Roadmap Taskforce formally established and to convene the Taskforce.

## **Annex C: Findings of Working Groups**

## Working group 1: Drivers and strategies

Questions given to Working Group: What are the main drivers of deforestation and forest degradation in Mongolia? What are the existing strategies being used to address these drivers? Which ones are working well? Which ones are not working well? What new strategies can be used to address deforestation/forest degradation that could be supported by REDD+?

#### **Working Group answers**

Members of the working group emphasized that fuel wood shouldn't be included as a driver.

The Working Group listed the following drivers:

- Forest disease
- No incentive for local people and voluntary rangers
- · High settlement and overgrazing
- Limited knowledge of forest protection
- No complete reforestation after usage
- Lack of forest measurement.

Working Group noted the following advantages:

- Someone is responsible for the forest protection, but economic interests are very high
- · Good legal environment, but lack enforcement
- Trees planting movement, but inadequate thinning and cleaning.

Working Group noted the following weaknesses:

- Lack of right of rangers and volunteer rangers
- No in timely fighting against <u>injurious</u> insects
- Lack of finance and resources
- Lack of mechanism for programme and project implementing in local level
- Unsustainable rules, regulations and management plan.

## **Working group 3: Reference Level and MRV**

### Questions and answers on how to develop a Reference Level?

Question: What current data do we have on forest cover in Mongolia? Include both boreal and Saxaul forests:

Answer: There is Info on Forest Inventory and management assessment at national level.

Question: What historical data do we have to establish the past rate of deforestation and forest degradation?

Answer: There is info of last 40 years

Question: What current data do we have on forest biomass and carbon stocks in Mongolia? Answer: National scientists are studying at the Mongolian National University forest biomass.

Question: What capacity building assistance is needed to build a comprehensive forest inventory?

Answer: Capacity building is very important. We should prepare specialists on carbon estimation and learn new techniques and technologies.

#### Questions given to Working Group on Measuring, reporting and verification (MRV):

Does Mongolia have reliable access to remote sensing data? How can it incorporate ground-based truthing of forest carbon changes? What are the opportunities for participatory forest monitoring? What lessons can be learned from existing projects? What are the current capacity and resource gaps for developing an MRV mechanism? How can emissions and removals from REDD+ be used to generate data on Land Use, Land Use Change and Forestry, so that it can be linked to the national greenhouse gas inventory which is the basis for reporting to the UNFCCC?

## **Working Group answers**

- It is possible to use satellite images.
- We could not estimate and measure sequestering (removing) CO<sub>2</sub> by increasing carbon stocks by using satellite images as there is no methodology or guidelines.
- Capacity Building and training is needed.
