## The UN-REDD Programme is...

- The United Nations Collaborative Programme on Reducing Emissions from Deforestation and Forest Degradation in Developing Countries
- Established in 2008 by FAO, UNDP and UNEP delivering as "One UN"
- Aim: Support developing countries build capacity to participate in a future REDD+ mechanism











### The UN-REDD Programme is...

- Developing countries across Africa, Asia-Pacific and Latin America and the Caribbean
- Donors
- IPs and Civil Society
- Agencies
  - FAO: Technical issues, forestry, natural resources, tenure
  - UNDP: National coordination, governance, stakeholder engagement
  - UNEP: Convening power, multiple benefits, REDD+ strategies and transformations to a low carbon economy
- Partners: FCPF, FIP, GEF, GCF...
- **Secretariat:** Coordination, quality assurance, programme monitoring, external relations





### The UN-REDD Programme in numbers

- 51 partner countries more than a third of the world's forests,
   and more than half the world's tropical forests
- 18 countries with National Programmes and growing
- US\$ 215M in donor contributions of which US\$ 70M
   allocated to National Programmes and US\$ 98M to SNA-GP
- 3,300+ REDD+ practitioners trained since 2010
- 950+ members of online community of practice (unredd.net)
- 1 million+ monthly website hits










### **UN-REDD Partner countries at a glance**



- Countries receiving support to National Programmes: Bangladesh, Plurinational State of Bolivia, Cambodia, Colombia, Democratic Republic of the Congo (DRC), Ecuador, Indonesia, Nigeria, Panama, Papua New Guinea, Paraguay, the Philippines, the Congo, Solomon Islands, Sri Lanka, the United Republic of Tanzania, Viet Nam and Zambia.
- Other partner countries: Argentina, Benin, Bhutan, Cameroon, the Central African Republic, Chile, Costa Rica, Côte d'Ivoire, Ethiopia, Gabon, Ghana, Guatemala, Guyana, Honduras, Kenya, the Lao Peoples' Democratic Republic, Madagascar, Malawi, Malaysia, Mexico, Mongolia, Morocco, Myanmar, Nepal, Pakistan, Peru, South Sudan, Suriname, Tunisia, Uganda and Zimbabwe.










## **The UN-REDD Programme DONORS**

# The UN-REDD Programme Governance

- Governed by Policy Board
  - 20 members
  - Bi-annual meetings
  - Supported by Secretariat
  - MPTF-O administers the UN-REDD Fund









### The UN-REDD Programme provides...

#### **Direct National Support**

- Comprehensive REDD+ readiness support through National Programmes to selected partner countries
- Targeted support and technical advice to all member countries
- Strong focus on country ownership and Indigenous Peoples' & civil society involvement

# Support to national actions (SNA)

- Development of tools, methodologies and guidelines
- Knowledge sharing and South-South collaboration
- Building of awareness of and support for REDD+ at national and international levels
- Secretariat services

Both levels working in close partnership with he FCPF and FIP, among other partners
