Programme Outcome(s): This budget revision restores funds to three Outputs (4.1, 4.3 and 4.4) and adds a new Output 4.6 under the existing Outcome 4.

Outcome 4: Indigenous peoples, local communities, civil society organizations and other stakeholders participate effectively in national and international REDD+ decision making, strategy development and implementation.

2. Executive Summary

The proposed budget revision for year two (2013) of implementation of the UN-REDD Programme "Support to National REDD+ Action: Global Programme Framework 2011–2015" (SNA) refers to Outcome 4. It aims to address the UN-REDD Programme Policy Board's recommendations at its ninth Policy Board Meeting held in Brazzaville, the Republic of the Congo, 26-27 October 2012, that the participating UN organizations explore the possibilities of strengthening support to Civil Society Organizations (CSO) and indigenous peoples and if additional funding becomes available particular attention be given to stakeholder engagement and related outputs under Outcome 4 - "Indigenous peoples, local communities, civil society organizations and other stakeholders participate effectively in national and international REDD+ decision-making, strategy development and implementation".

Having received new funds by the beginning of 2013 that exceeded the projections made in October 2012 due to a higher contribution from Norway, the participating UN organizations request the Policy Board to approve the revised work plan and budget of the SNA to allocate US\$ 4,380,000 to additional activities within Outcome 4 as follows:

- US\$380,000 to restoration of the budget for Outputs 4.1, 4.3 and 4.4 for year 2 (2013) of the SNA with a view to support progress on REDD+ and address the needs of strengthening the engagement of indigenous peoples and forest dependent communities in REDD+;
- ii) US\$4,000,000 to support to community based REDD+ in collaboration with the Small Grants Programme of the GEF under a new Output 4.6.

3. Background

The UN-REDD Programme aims to contribute to REDD+ readiness at national, regional and global level. The UN-REDD Programme SNA focuses on supporting countries in their REDD+ efforts through the development of common approaches, analyses, methodologies, tools and data, and sharing of best practices. The SNA also provides the infrastructure for UN-REDD Programme knowledge management and exchange of experiences as well as promotion of South-South cooperation. The SNA stems from the UN-REDD Programme Strategy 2011-2015 and the lessons learned from the implementation of the Global Programme 2009–2011. The SNA comprises eight outcomes, which are broken down into 34 outputs as shown in the SNA Monitoring Framework¹.

Following the Policy Board's request at its seventh Meeting for a review of the SNA's budget to be conducted, taking into consideration the results of the Country Needs Assessment (CNA), a revised budget for years 2 and 3 of the SNA (2013-2014) was approved by the Policy Board at its ninth Meeting, in Brazzaville, the Republic of the Congo, October 2012. The review resulted in fully revised outputs, indicative activities and associated budget, and in a reduction of 14% of the budgets for 2013 and 2014. When approving the budget review, the Board recommended that the participating UN organizations explore possibilities of strengthening support to CSOs and indigenous peoples. The

Board also recommended that if additional funding becomes available, particular attention be given to stakeholder engagement and related outputs under Outcome 4.

In the beginning of 2013 the funding situation of the UN-REDD Programme was improved by contributions from the Governments of Norway and Luxembourg and the EC. Particularly, Norway made a contribution significantly higher than its original pledge. Following the announcement of the contribution from Norway to the UN-REDD Programme for 2013 of US\$35 million, the Policy Board adopted on 31 May 2013 an inter-sessional decision to invite three countries (Argentina, Bangladesh and Cote d'Ivoire) to submit their respective National Programmes for consideration at the eleventh Policy Board Meeting. Alongside this decision adopted by the Policy Board to invite the three countries for submission of their National Programmes, the Participating UN Organizations planned a reinforced budget for stakeholder engagement.

In response to the guidance from the ninth Policy Board Meeting regarding enhanced support to CSOs and indigenous peoples, it is herein proposed that the Board considers a revision of the SNA budget for 2013 to include:

- Restoration of part of the reductions applied to Outcome 4 of the SNA (Outputs 4.1², 4.3 and 4.4, related to strengthening capacity of indigenous peoples and Civil Society in REDD+); and
- ii) A new output under Outcome 4, focused on support to Community-Based REDD+ (CBR+).

With this budget revision, the overall formulation of the SNA Programme remains the same as per the original document "Support to REDD+ National Action(SNA) Global Programme Framework 2011-2015", signed by FAO, UNDP and UNEP and approved by the Policy Board on 9 August 2011.

3.2. Summary of additional activities

3.2.1 Support to the full and effective engagement of indigenous peoples and civil society in REDD+

The SNA Outcome 4, focusing on the work of supporting stakeholder engagement in REDD+ national and international processes, continues to be one of the main pillars of the Programme. The UN-REDD Programme has invested strongly in supporting stakeholders to engage in and influence national and international REDD+ processes. This work is appreciated for its effective results by stakeholders.

The amount of US\$1,866,502 formerly planned for 2013 for outputs that are directly related to supporting indigenous peoples, local communities and civil society (Outputs 4.1, 4.2, 4.3 and 4.4), underwent a reduction of US\$443,866, for a final request of US\$1,422,636. It was originally assumed that as this activity became more mature, the associated budget at the global level could gradually

be reduced, as reflected in the budget request of October 2012. However, it is clear from feedback received from stakeholders over the last year that indigenous peoples and CSO stakeholders require more continuous support to ensure their full and effective engagement. Since the last quarter of 2012 the UN-REDD Programme has provided countries with the direct technical support of dedicated regional Stakeholder Engagement Specialists, expanding the reach and level of support to partner countries. This has allowed the UN-REDD Programme to more accurately identify stakeholder engagement needs that the reduced budget does not currently cater for. Responding to the reality that mainstreaming stakeholder engagement in countries calls for investment and technical assistance, the Policy Board recommended that if additional funding becomes available, particular attention be given to stakeholder engagement and related outputs under Outcome 4.

The current funding status of the Programme allows a restoration of the budget of Outputs 4.1, 4.3 and 4.4 with a total amount of US\$380,000. These funds will be channeled to activities that were reduced in scope due to the budget reduction in 2013 and to provide greater support to governments and indigenous peoples and CSO stakeholders within partner countries in line with the recommendations of the CNA. It is suggested to allocate the restored amount as follows:³

Output 4.1: Indigenous Peoples, local communities, civil society organizations, and other relevant stakeholders are informed of national and international REDD+ processes, policies and activities.

The amount under the Output for 2013 as per the budget review 2013-2014 was US\$85,030 (23%). The amount being restored is US\$133,750.

The re-instated funds will be used to:

- Fund additional activities to support the IP and CSO Representatives to the Policy Board to inform and consult with their constituents in the regions.
- Support knowledge exchange activities for IP and CSO networks outside those represented on the Policy Board to ensure that they are informed on REDD+⁴ (examples of such activities carried out this year include a workshop on stakeholder engagement and anti-corruption coorganized with the Amazon Basin IP network COICA⁵ in April 2013).
- Scale up knowledge management activities to better capture lessons on the ground and communicate these to stakeholders.

Output 4.3: Support for the implementation of effective stakeholder engagement practices and guidelines in REDD+ countries.

The amount under this Output for 2013 as per the budget review 2013-2014 was US\$85,846 (14%). The amount being restored is US\$144,450.

The re-instated funds to Output 4.3 will be used to:

- Fund further activities to support countries to implement guidelines and standards (e.g., develop train-the-trainers modules and programme, support the development of tailored country level guidance).
- Pilot the Guidelines on Free, Prior and Informed Consent (FPIC) in countries (examples from activities being conducted in 2013 include a project developed jointly with the Government

to create national FPIC guidelines for Viet Nam, support to ongoing processes to revise draft FPIC guidelines in Papua New Guinea).

• Develop a system to review and assess the implementation of guidelines on stakeholder engagement at the national level, and use this system to identify weaknesses in national stakeholder engagement systems and provide support to countries accordingly.⁶

Output 4.4: Stakeholders are supported to engage in and influence national and international REDD+ processes

The amount under the Output for 2013 as per the budget review 2013-2014 was US\$327,184 (63%). The amount being restored is US\$101,800.

The re-instated funds to Output 4.4 will be used to:

- Build the capacity of IP and CSO stakeholders and improve their abilities to engage in REDD+ decision-making processes alongside government institutions.⁷
- Support IP and CSO stakeholder networks outside those represented on the Policy Board to engage in regional and/or international REDD+ decision making processes through supporting platforms for stakeholder engagement and supporting key networks to participate in important decision-making activities/events.

3.2.2 Support to Community-Based REDD+ (CBR+)

The new activities under Outcome 4 (*Indigenous peoples, local communities, civil society* organizations and other stakeholders participate effectively in national and international REDD+ decision-making, strategy development and implementation) are summarized in the revised workplan and budget 2013 seen in Table 1.

Experience shows that community-based organizations and local civil society groups are often the primary organizing bodies and normative institutions in rural regions and if REDD+ activities are to have relevance and traction with the most vulnerable and marginalized communities, funding of community-based activities must be given due consideration. Local level interventions present a distinct opportunity to tap into the capacity and local knowledge of indigenous peoples and other forest-dependent communities. Such approaches have the added advantages of versatility, flexibility and rapidity, and of being low-cost solutions for getting REDD+ approaches right. Community-based approaches can complement national REDD+ action, and successful activities and best practice can be scaled up to the national level.

The CNA supports the advent of CBR+ by pointing to an urgent need to strengthen the capacity of community groups and local NGOs to participate in REDD+ strategies, as well as the importance of piloting safeguards and free, prior and informed consent (FPIC) and other ways to create interest in REDD+ and value for local communities.⁸ The UN-REDD Programme seeks to address this need through the creation of an Output 4.6: *Stakeholders at the community level engage in and contribute to the implementation of REDD+ Readiness through community-based REDD+*. Building upon the

growing collaboration between the UN-REDD Programme and the Global Environment Facility (GEF), Output 4.6 while being financed the UN-REDD programme, the GEF Small Grants Programme (SGP) has committed to equal level financing, leveraging the respective operational and technical expertise of these two programmes to efficiently support the implementation of REDD+ activities at the local level. To reduce entry costs and avoid reinventing a disbursement mechanism where a successful model already exists, Output 4.6 proposes building on SGP's wealth of local experience and established country presence, by leveraging SGP funds alongside UN-REDD Programme funds to contribute to national and global REDD+ objectives more systematically.

The CBR+ will build on the UN-REDD Programme's National Programmes, technical expertise and partnerships with key national REDD+ actors, and it will collaborate closely with other related initiatives, for example, the FCPF, the Forest Investment Program (FIP), the Forest and Farm Facility (FFF) and the EU FAO Forest Law Enforcement and Governance (FLEGT) Programme. The potential pilot countries are those which have both a UN-REDD National Programme and an established SGP Programme, and which are deemed to have sufficient absorptive capacity.

The main objective of the CBR+ is to catalyze REDD+ readiness from the ground up, bringing resources and capacity to communities, empowering them to engage in national REDD+ activities and pilot important REDD+ methodologies and approaches. Specifically, CBR+ will:

- Activate and support community-based action and build capacities to improve equitability and effectiveness in the implementation of REDD+ readiness;
- Support countries to implement the UNFCCC safeguards and UN-REDD Guidelines to ensure the full and effective participation of indigenous peoples, civil society and marginalized groups such as women and the poor in REDD+;
- Ensure critical links and improved coordination between community grants within the biodiversity, climate change and land degradation focal areas of the SGP and national REDD+ activities under the UN-REDD Programme, thereby multiplying potential impacts and results;
- Support learning and sharing of lessons drawn from community-based experiences in support of REDD+.

The proposed allocation of US\$4 million will leverage an equivalent US\$3,926,000 of co-financing in grants and operational support that will magnify the scope and reach of Output 4.6 in 2013. See Table 1 for the accompanying detailed budget and the associated co-financing from SGP.

3.3. Work plans and budgets

Table 1 describes the budget allocations and work plan for the new Output 4.6 and the amounts to be restored to the outputs under Outcome 4.

The budget revision implies an overall increase in the SNA budget of 19% in comparison with the annual budget for 2013. Regarding the SNA categories of support⁹, the budget revision implies allocation of 62% of the Outcome 4 budget (Outputs 4.1-4.6) to country specific support, while 38%

will be allocated to international support functions. The additional funds under Output 4.6 for CBR+ are 77% allocated to country specific support and 23% allocated to international support functions. Through the introduction of the CBR+, the support provided as country specific will be meaningfully strengthened, as the budget for Outcome 4 for 2013 as approved in the budget review had only 49% allocated to country specific support. For the overall SNA, however, the ratio of the three categories of support of the SNA budget of 2013 including the revision will not significantly change.

4. Conclusion

In order to support progress on REDD+ and address the needs of strengthening the engagement of indigenous peoples and forest dependent communities in REDD+, the participating UN organizations request the Policy Board to approve the revised work plan and budget for year 2 (2013) of the SNA, and the associated additional budget allocation of US\$4,380,000 for 2013 within Outcome 4 as follows:

- i) US\$380,000 to the restoration of part of the reductions applied to Outcome 4 of the SNA (Outputs 4.1¹², 4.3 and 4.4, related to strengthening capacity of indigenous peoples and Civil Society in REDD+); and
- ii) US\$4,000,000 to the new Output 4.6, "Stakeholders at the community level engage in and contribute to the implementation of REDD+ Readiness through community-based REDD+, focused on support to CBR+.

The other Outputs and Outcomes under the SNA remain as per the work plan and budget outlined in the <u>Support to National REDD+ Action: Global Programme Framework 2011-2015 Budget Review</u> <u>2013-2014</u> and the overall formulation as per the original document "Support to REDD+ National Action (SNA) Global Programme Framework 2011-2015".

The total amount allocated to the SNA, considering the proposed budget revision is US\$77,585,313 (until 31 December 2014).

Overall, the ratio of the three categories of support (international support functions; country specific support and secretariat) of the delivery of the SNA budget in 2013, including the revision, will not significantly change.
