Pre-Policy Board Information Day Wednesday, 20 May 2015

1. UN-REDD Programme 2016-2020 Strategic Framework (2hrs)

Context: This session will recap the process undertaken in the development of the UN-REDD Programme 2016-2020 Strategic Framework, highlight updates in the document since PB13 and introduce the governance arrangements for the UN-REDD Programme 2016-2020. It will provide an opportunity to raise any questions or clarification in advance of the scheduled Policy Board discussion.

2. Addressing drivers of deforestation and forest degradation (2hrs)

Context: The session will address emerging experiences in addressing drivers of deforestation and forest degradation (DDFD), derived from a global analysis of the UN-REDD Programme portfolio as well as specific country level examples. The session is structured around three key pillars:

- (i) Analyzing dynamics of DDFD;
- (ii) Addressing DDFD: illegal logging; and
- (iii) From analyses to monitoring.

Session 3 – Strategic and Policy Issues: UN-REDD Programme 2016-2020 Strategic Framework and its Governance arrangements (4.5hrs)

Context: The Secretariat will present the UN-REDD Programme 2016-2020 Strategic Framework for consideration and endorsement, along with information note on governance arrangements and on the roadmap for launching the UN-REDD Programme 2016-2020.

Session 4a – National Programme Updates: Countries invited for an informal presentation for new National Programmes (2hrs)

Context: At the 12th Policy Board meeting held in Lima, the Board approved a revised process for the establishment of a pipeline for invitation of countries for the submission of National Programmes consisting of (i) a call for expressions of interest; (ii) a selection lead by a reactivated policy board working group. Following the pledge by Norway at PB13 in Arusha and the transfer of funds in March 2015, 12 Expression of Interest were received. As a first group, 3 new countries can be invited for the submission of National Programmes, notably Chile, Myanmar and Peru. The session will provide a short update on the process and criteria of selection, and informal presentations by each country on the foreseen National Programme.

Session 4b - Final Evaluation of Ecuador's National Programme: Sustaining the gains (1hr)

Context: Ecuador's UN-REDD National Programme operationally closed in December 2014, with a financial closure in June 2015. A final independent evaluation was carried out over the last quarter of 2014 which informed a management response. The full evaluation report, as well as an executive summary, is available on the UN-REDD Programme Workspace. The representative of Ecuador will present the key findings and recommendations of the final evaluation, Ecuador's management response as well as the final, forward looking perspectives following closure of the National Programme.

Session 5 – SNA Update: Country Needs Assessment (1hr)

Context: The Secretariat will provide an overview of the Country Needs Assessment process, the thematic distribution, coordination and a status update on implementation. As a result of the call for proposals issued in April 2014 by the UN-REDD Programme, seven countries (Guatemala, Madagascar, Malawi, Peru, South Sudan, Tunisia and Zimbabwe) and two Regions (Mesoamerica and West Africa) are at various stages of implementation of their proposed Country Needs Assessments. Several countries/regions will provide their perspectives on the CNA.
