# Regional Stakeholder Consultation Workshop: Cox's Bazar

19<sup>th</sup> December 2011


## **Summary**

Following the UN REDD national consultation workshop in October 2011 the second in a series of regional consultation workshops took place on 19<sup>th</sup> December 2011 at Cox's Bazar. This workshop involved 80 participants from two south-east regions of Bangladesh: Coxs Bazar district and Teknaf Coastal Forest area. The objective of this session was to bring out the root causes of deforestation and degradation of forest as well as to capture the recommendations/ strategies from the stakeholders in dealing with such consequences. The participants ranged from the regional Government officers of Forest Department to remote villagers, which led to an enlightening exchange of views. The inclusion of University, Research organizations and CSOs further bridged the gaps of discussion in dealing with the continuum of livelihood security at one end and social welfare on the other. At this outset information has been gathered from the regional context, which will be incorporated in the REDD+ Readiness Roadmap preparation for Bangladesh. There will be more upcoming workshops at the regional and local level as per the coverage of forest areas in Bangladesh and UNDP will provide its support as mandated.

### **Group Formation:**

Total 80 participants joined the session and they were divided into two groups namely Coastal Forest and Hill Forest which had two sub groups as depicted below.

#### Key observations:

- Instead of "Deforestation" and "Degradation" we can use the Bengali term "Bon Ujar" and "Bon Obokkhoy" which is easier for the locals to catch up.
- Both the Government and Non Government participants agreed on the causes in a non confrontational way
- Spontaneous participation of impacted community from the remote areas of Teknaf,
   Ukhia, Chunati and FasiaKhali is mention worthy
- A simple standard pictorial definition of Deforestation and Degradation can reduce the time for the facilitators to bring participants on a single platform of understanding
- Frustration was evidenced from the Government officers in explaining the harmony between the recommendations of FD and the actions taken by the DC
- Facilitators having the knowledge of local dialect can break the ice more comfortably when interaction is with the villagers and root level community
- Half day session is a bit tight instead couple of hours after lunch can be extended for better result
